The Diseases of Animals (Approved Disinfectants) (Amendment)
(No. 2) Order 1991

(SI 1991 No. 631)

This Order revokes and replaces the Diseases of Animals (Approved Disinfectants) (Amendment) Order 1991. It amends the Diseases of Animals (Approved Disinfectants) Order 1978, by substituting new Schedules for Schedules 1 and 2 to that Order (article 2(a) and (b)). Schedule 1, which lists approved disinfectants, includes newly approved disinfectants, and Schedule 2 lists disinfectants which are now omitted from Schedule 1 but which may nevertheless continue to be used as approved disinfectants until 30th June 1991, (article 2(c)).
