

LONDON BOROUGH OF REDBRIDGE

London Borough of Redbridge, Forest Road, Hainault Permanent Waiting Restrictions (Waiting and Loading Restriction) (Amendment No. 1) Order 1991.

Notice is hereby given that the London Borough of Redbridge, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred under sections 6 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, made the above-mentioned Order on 29th April 1991.

The general effect of the Order will be to continue in force indefinitely the provisions of the Redbridge (Waiting and Loading Restriction) (No. 2) Experimental Traffic Order 1989 so as to make permanent those waiting restrictions in Forest Road as defined in the attached Schedule.

The Order will come into operation on 12th May 1991.

Copies of the Order, of the above-mentioned Experimental Order, together with a map of the area and the Council's statement of reasons for making the Order may be inspected during normal office hours, on Mondays to Fridays inclusive, at the Information Centre, Town Hall, High Road, Ilford, Essex until 30th June 1991.

Any person wishing to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

*Forest Road, Hainault**10 a.m. to 11 a.m. Monday to Friday, Waiting Restrictions*

(a) The north-west side:

- (i) between a point opposite the party walls of Nos. 3 and 5 Forest Road and a point 2 metres south-west of the party wall of Nos. 7 and 9 Forest Road, Hainault.
- (ii) between a point 3 metres north-east of the party wall of Nos. 7 and 9 Forest Road and the common boundary of Nos. 29 and 31 Forest Road, Hainault.
- (iii) between a point 5 metres north-east of the common boundary of Nos. 29 and 31 Forest Road and a point 2 metres north-east of the common boundary of Nos. 61 and 63 Forest Road, Hainault.
- (iv) between a point 7 metres north-east of the common boundary of Nos. 61 and 63 Forest Road and a point opposite the north-eastern boundary of No. 6 Railway Cottages, Forest Road, Hainault.

The Borough of Oadby and Wigston (Wigston Road and Rosemead Drive, Oadby) (Prohibition of Waiting) Order 1991

Notice is hereby given that the Borough of Oadby and Wigston (acting as agent for the Leicestershire County Council) propose to make an Order under section 1(1) and (2), 2(1) to (3) and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to prohibit waiting by vehicles at all times on:

- (a) *Wigston Road, Oadby (B528)*; the south side from a point 15 metres north-east of its junction with Rosemead Drive, for a distance of 500.8 metres in a south-westerly direction to the boundary between properties numbered 203-205 Wigston Road; and on the north side:
 - (i) from a point 27.43 metres north-east of the junction with Brabazon Road, for a distance of 130 metres in a north-easterly direction to a point 15 metres beyond the service road, and
 - (ii) from a point 27.43 metres south-west of its junction with Brabazon Road for a distance of 357 metres to a point opposite the boundary between properties numbered 203-205 Wigston Road.

- (b) *Rosemead Drive, Oadby*, on both sides from its junction with Wigston Road for a distance of 15 metres in a south-easterly direction.
