

## SOUTH BEDFORDSHIRE DISTRICT COUNCIL

*The South Bedfordshire District (On-Street Parking Places) Order 1991*

Notice is hereby given that the South Bedfordshire District Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Bedfordshire County Council in exercise of the powers of the said County Council under sections 32(1) and 35(1) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other powers, them enabling in that behalf, and with the consent of every authority and person responsible for the maintenance of the roads affected by this Order and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, propose to make the following Order:

- (a) To revoke completely The South Bedfordshire District (High Street, Leighton Buzzard On-Street Parking Places) Order 1988—the provisions revoked in this 1988 Order are as set out in part 1 of the Schedule to this notice.
- (b) Revoke the provisions contained in The South Bedfordshire District (On-Street Parking Places) Order 1988 and re-introduce them in so far as they apply in respect of Lake Street, Leighton Buzzard and George Street, Dunstable—the provisions revoked in this 1988 Order are as set out in part 1 of the Schedule to this notice.
- (c) Introduce the new provisions as set out in part 2 of the Schedule to this notice but subject to the limitations stated in columns 2 to 6.

The draft Order together with the maps showing the parking places concerned with a statement of reasons for the proposals may be examined at either the offices of the District Secretary, The District Offices, High Street North, Dunstable, or the offices of the Leighton-Linslade Town Council, Bossard House, West Street, Leighton Buzzard, between the hours of 8.45 a.m. and 4.45 p.m., Mondays to Fridays.

If you wish to object to or make representations on the proposals you should write giving your grounds for objection to the Director of Technical Services, at the address shown below by 3rd June 1991.
