- (ii) from its junction with Acland Road eastwards to a point 41 metres thereof.
- (b) Prohibit waiting at any time on Wollaston Road
 - (i) on its southern side between points 87 metres and 106 metres west of its junction with Icen Way;
 - (ii) on its northern side for its entire length.
