

## LONDON BOROUGH OF ENFIELD

*Aylands Road/Larmans Road, Freezywater—Waiting Restrictions*

Notice is hereby given that the Council of the London Borough of Enfield on 7th May 1991 made the Enfield (Waiting and Loading Restriction) (Amendment No. 136) Order 1991 under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.

The general effect of the Order will be as described in the notice of proposals, ref. 765, published in the *London Gazette*, issue number 52474, dated 13th March 1991.

A copy of the Order, which will come into operation on 20th May 1991, of a map indicating the location and effect of the Order, of the Council's statement of reasons for proposing to make the Order and of the Enfield (Waiting and Loading Restriction) Order 1979 (and of the Orders which have previously amended that Order) can be inspected at the Reception Desk, "B" Block, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD, during normal office hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Order was made.

Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof, or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

## LONDON BOROUGH OF ISLINGTON

*Designation of a Doctor's Parking Place*

Notice is hereby given that Islington Borough Council proposes to make an Order under sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 which will be known as the Islington (Doctor Parking Places) (Amendment No. 3) Order 1991.

The general effect of the Order will be to:

- (a) designate a doctor's parking place on the highway specified in column 1 of the Schedule to this notice;
- (b) provide that:
  - (i) a vehicle displaying a permit issued under the Order may be left in the parking place;
  - (ii) the parking place will be in operation between 8 a.m. and 8 p.m. on any one day of the week;
  - (iii) a permit may be issued by the London Borough of Islington on application being made by certain legally qualified medical practitioners. (NOTE—a permit in respect of the parking place on the highway specified in column 1 of the Schedule to this notice will be issued only in connection with the medical practice specified in relation thereto in column 2 of the said Schedule); and
  - (iv) the charge in connection with the issue of a permit will be £84 in respect of the parking bay and that the permit will be valid for a period of 12 months.

A copy of each of the Orders, of the above-mentioned Order of 1977 and of the Orders which have previously amended or applied that Order; a copy of the maps which indicate each length of highway to which the Order relates and a copy of the statement of reasons for making an Order, may be inspected during normal office hours Mondays to Fridays at the following locations for a period of 21 days from the date the Order was made:

## LONDON BOROUGH OF MERTON

*London Borough of Merton (Free Parking Places) (Disabled Persons) (No. ) Traffic Order 1991*

*Ashtree Avenue, Buckleigh Avenue, Chatsworth Avenue, Kenilworth Avenue, Nelson Road, Newton Road, Panmuir Road and Southey Road.*

Notice is hereby given that the Council of the London Borough of Merton under the powers conferred by section 6 of the Road Traffic Regulation Act 1984, propose to make the above-mentioned Order.

The general effect of the Order will be to:

- (a) designate a single parking place in Buckleigh Avenue, Chatsworth Avenue, Nelson Road and Newton Road in which vehicles authorised by the Order may be left for any period during the permitted hours without charge;
- (b) provide that the parking places will operate between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (c) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Orange Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982 may be left therein; and
- (d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.
- (e) revoke the parking places in Ashtree Avenue (opposite Nos. 34 and 36), Kenilworth Avenue (opposite Nos. 31 and 33), Panmuir Road (opposite Nos. 35 and 37), and Southey Road (approximately 11 metres south of No. 6).

Nothing in the Order shall apply to anything done with the permission or at the direction of a police constable in uniform.
