BEDFORDSHIRE COUNTY COUNCIL

The County of Bedfordshire Propose to Prohibit the Waiting of Vehicles (Except Buses) on the Bus Stop area, on the A6001 Church Street, Langford between 7 a.m. and 7 p.m.

Notice is hereby given that Bedfordshire County Council proposes making a Road Traffic Regulation Order as follows:

Effect of the Order: to prohibit all vehicles, except buses from stopping within the confines of the bus stop area indicated below on any day between the hours of 7 a.m. and 7 p.m.:

"That length on the west side of Church Street, Langford (A6001) from a point approximately 27 metres north of Mill Lane (UC.376) in a northerly direction for a distance of approximately 50 metres."
