#### TENDER FOR STERLING TREASURY BILLS

The Lords Commissioners of Her Majesty's Treasury, hereby give notice that Tenders will be received at the Securities Office, Bank of England, Threadneedle Street, on Friday, 24th May 1991, at 1 p.m. for sterling Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £200,000,000 for Bills due 63 days after date, £500,000,000 for Bills due 91 days after date and £200,000,000 for Bills due 182 days after date.

- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the Tenderer on any business day from Tuesday, 28th May 1991 to Friday, 31st May 1991, inclusive.
  - 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the day on which the Bills required are to be dated and the net amount per cent (being a multiple of half of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates and different tenors.
- 5. Notification will be sent on the day of the Tender to the persons whose Tenders are accepted in whole or in part.
- 6. If delivery of Treasury Bills into the Central Moneymarkets Office has been requested, payments will be effected through that system; otherwise payment in full of the amount due in respect of an accepted Tender must made to the Bank of England, not later than 1.30 p.m. on the day on which the relevant Bills are to be dated and on which they are to be collected from the Securities Office, by one of the following means:
  - (a) cash.
  - (b) banker's draft payable through the Town Clearing,
  - (c) cheque drawn on the Bank of England,
  - (d) CHAPS payment (subject to evidence of payment):
  - (Bills will only be released by the Bank of England when evidence of payment has been received).
- 7. Tenders must be made on the printed forms which may be obtained from the Securities Office, Bank of England. Particular forms are available for Bills of each maturity.
- 8. The Lords Commissioners of Her Majesty's Treasury reserve the right to reject any Tenders.

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To Jwad K. Abbod Mahbooba, Kadisia, Iraq (Our Ref. CDB3A/514/90)

Pursuant to section 139(6) of the Customs and Excise Management Act 1979, and Paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that certain goods, namely:

Electronic control devices and microchips

presented for export to Iraq on 5th October 1990, have been seized on the grounds that they were brought to a place in the United Kingdom namely London Heathrow Airport, for export in contravention of the prohibition imposed by the Export of Goods (Control) (Iraq and Kuwait Sanctions) Order 1990, made under the Import, Export and Customs Powers (Defence) Act 1939, and are liable to forfeiture under section 3(1) of the same Act and section 68 of the Customs and Excise Management Act 1979.

If you claim that the goods are not liable to forfeiture, you must within one month from the date of this notice of seizure give notice of your claim in accordance with Paragraph 3 of Schedule 3 to the Customs and Excise Management Act 1979. If you make such a claim within that time, legal proceedings will be taken for the condemnation of the goods. These are civil proceedings at which you should attend or be legally represented to show cause why the goods should not be condemned. It will be a matter for the court to decide whether or not the goods should be condemned and forfeiture confirmed. If no such claim is made, the goods will be considered to have been duly condemned as forfeited.

If you are outside the United Kingdom and the Isle of Man, you must also give the name and address of a solicitor in the United Kingdom who is authorised to accept service of process and act on your behalf.
