### EUROPEAN COMMUNITY CERTIFICATES OF ORIGIN

The Department of Trade and Industry (the DTI) announced on 10th March 1989 ('British Business') that it had commissioned a comprehensive policy review of the Certificate of Origin Scheme (the Scheme). Following this Review, and subsequent negotiations with the Association of British Chambers of Commerce (ABCC), it was concluded that clarification was appropriate to confirm that Certificate of Origin issuing bodies currently designated for the purposes of the 1923 League of Nations' International Convention are also authorized under the relevant EC legislation. \*These issuing bodies have sub-offices which provide a certification service. Enquire at the main office for details.

On behalf of the DTI, the ABCC is the manager and administrator of the Scheme, and advises the DTI on the competence of currently authorized and applicant issuing bodies. The conditions, standards, rules and regulations under which issuing bodies operate, are prepared by the ABCC in consultation with the DTI. The Association advises issuing bodies on the standard charges to be made to persons wishing to obtain Certificates of Origin.

Applicants seeking authorization to issue Certificates of Origin that are universally acceptable to foreign customs authorities under the provision of international conventions and EC legislation should apply in the first instance to the Association of British Chambers of Commerce, Sovereign House, 212a Shaftesbury Avenue, London WC2H 8EW, who will make appropriate recommendations to the DTI on these matters. The DTI has sole power to grant and withdraw authorization. Action may be taken as appropriate against unauthorized issuers.

### Information for Exporters

Overseas customs authorities may refuse Certificates of Origin other than those issued by organisations authorized by the DTI (listed above). Exporters are advised that difficulties may arise over documents certifying origin which do no more than authenticate the signature of the declarer (even if the signature of the declarer is later officially authenticated).
