TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of a length of Bristol Mews, London W.9 to enable redevelopment of the site by the erection of twenty-six mews houses with integral car parking to be carried out in accordance with planning permission granted to Ergon Design Group and Day & McLoughlin.

The County Council of the Royal County of Berkshire (Wokingham Inner Distribution Road Classified Road) (Side Roads) Order 1989

The Secretary of State for Transport hereby gives notice that he has confirmed with modifications the above Order which was made by the County Council of the Royal County of Berkshire under sections 14 and 125 of the Highways Act 1980 and which, as confirmed, authorises the Council:

- (a) to carry out the improvement of highways,
- (b) to stop up highways,
- (c) to construct new highways,
- (d) to stop up private means of access to premises, and
- (e) to provide new means of access to premises,

all on or in the vicinity of the route of the Classified Road being:

- (1) Wellington Road from its junction with Elms Road south-eastwards to its junction with Finchampstead Road and Denmark Street;
- (2) the highway which the Council proposes to construct from the junction of Wellington Road, Finchampstead Road and Denmark Street north-eastwards to the junction of Langborough Road and Gipsy Lane;
- (3) the highway which the Council proposes to construct from the junction of Langborough Road and Gipsy Lane north-eastwards to a point on Sturges Road 25 metres south of its junction with Denton Road;
- (4) the highway which the Council proposes to construct from a point on Sturges Road 25 metres south of its junction with Denton Road north-eastwards to a point on Easthampstead Road 25 metres north-west of its junction with Westcott Road;
- (5) the highway which the Council proposes to construct from a point on Easthampstead Road 25 metres north-west of its junction with Westcott Road north-eastwards to a point on London Road 160 metres west of its junction with Seaford Road;
- (6) the highway which the Council proposes to construct from a point on London Road 160 metres west of its junction with Seaford Road, northwards to a point on Norreys Avenue 175 metres north-east of its junction with Wiltshire Road;
- (7) the highway which the Council proposes to construct from a point on Norreys Avenue 175 metres north-east of its junction with Wiltshire Road westwards to the junction of Wiltshire Road and Rectory Road;
- (8) Rectory Road from its junction with Wiltshire Road westwards to its junction with Glebelands Road;
