West Park Street, Southerly footway from Ordsall Drive to a point 30 metres north-west of Buckfield Avenue, a total area of approximately 1,110 sq. metres.

Description of the Area to be Closed:

West Park Street—north-easterly footway only, from Sunnyside Court to Sandiway, a total area of approximately 498 square metres

Footpath to the rear of 6 Garnet Wolseley, between West Park Street and Robert Hall Street, a total area of approximately 815 square metres

Garnet Wolseley Avenue,—from West Park Street to the footpath adjacent to 1 Garnet Wolseley (between Sunnyside Court and Stoneway) a total area of approximately 972 square metres

Footpath adjacent to 1 Garnet Wolseley, between Sunnyside Court and Stoneway, a total area of approximately 115 square metres

Stoneway—between West Park Street and Park Lodge, a total area of approximately 578 square metres
