The Secretary of State for Transport hereby gives notice that he proposes to make the following Orders:

An Order under sections 10 and 41 of the Highways Act 1980 which will provide that

- (a) the road ("the main road") which he proposes to construct along a route, approximately 5-4 kilometres in length, starting at a point about 285 metres north of the centre line of the bridge carrying the A167 Trunk Road over the B6532 road then going in a southerly direction (crossing beneath the Newcastle to London Railway line) and continuing in a southerly direction generally parallel to that railway line to terminate at a point on the A167 Trunk Road about 430 metres south of the centre of the Cock O' the North Roundabout.
- (b) a road 445 metres in length starting at a point 125 metres south of the centre of the Cock O' the North Roundabout and terminating at a point on the A167 Trunk Road 530 metres south of the centre of the Cock O' the North Roundabout, and
- (c) slip roads (to connect the main road to roundabouts to be constructed as part of existing roads pursuant to the side roads order)

shall become trunk roads as from the date when the Order comes into force

An Order under sections 10 and 12 of the Highways Act 1980 which will provide that the length of the A167 Trunk Road from a point 50 metres north of the centre of the Sniperley Park Roundabout to a point 25 metres south of the centre of the Cock O' the North Roundabout, a distance of about 4.2 kilometres, shall cease to be a trunk road and shall (from the date on which the Secretary of State notifies the County Council of Durham that the main road is open to through traffic) be classified as a principal road.

An Order under sections 12, 14 and 125 of the Highways Act 1980 authorising him:

- to improve highways;
- (b) to stop up highways
- to construct new highways; (c)
- to stop up private means of access to premises, and
- to provide new means of access to premises,

all in the vicinity of the routes of one or more of the new trunk roads (described in paragraph 1 above), or the A167 Trunk Road and providing for the transfer of each of the said new highways to the County Council of Durham as from the date on which he notifies the Council that they have been completed and are open to through traffic.

An Order under sections 1(1) and (2) and 2(1) and (2) of the Road Traffic Regulation Act 1984 which will provide that no vehicle shall proceed in that length of the A167 Trunk Road from a point 720 metres north of the centre of the Sniperley Park Roundabout to its junction with that roundabout in any direction other than southwards as from the date on which the main new trunk road is opened to through traffic.
