*The A12 Trunk Road, (Eastern Avenue, Redbridge) (Prohibition of Right Turn and U-Turns) Order 1991*

The Secretary of State for Transport hereby gives notice that he proposes to make the above-named Order the effect of which would be to continue in force indefinitely the provisions of an experimental traffic Order made in February 1990:

- (a) to prohibit the right turn from The Drive into Eastern Avenue, Ilford, Essex; and

#### ROAD TRAFFIC REGULATION ACT 1984

*The A45 Trunk Road, (Eltisley Bypass) (De-Restriction) Order 1991*

#### ROAD TRAFFIC REGULATION ACT 1984

*The A10 Trunk Road (Milton Bypass) (De-restriction) Order 1991*
