#### PART I

## Rights of Way to be Suspended

Bridleway No. 26 in the community of Rhymney commencing from its junction with C.R.F.22 and C.R.F.28, approximately 480 metres north of Brynawel Bungalow, and extending in an easterly direction to terminate on its junction with Bridleway No. 34 and Bridleway No. 35, approximately 358 metres from the said point of commencement. (A-B).

Bridleway No. 30 in the community of Rhymney commencing from its junction with Bridleway No. 31 and Bridleway No. 32, approximately 300 metres north east of Brynawel Bungalow, and extending in a south south westerly direction for approximately 220 metres, to terminate at its junction with Bridleway No. 29 and Bridleway No. 31, approximately 160 metres east of the said Brynawel Bungalow. (C-D).

Bridleway No. 31 in the community of Rhymney commencing from its junction with Bridleway No. 30 and Bridleway No. 32, approximately 300 metres north east of Brynawel Bungalow, and extending in a southerly then west south westerly direction for approximately 275 metres, to terminate on its junction with Bridleway No. 29 and Bridleway No. 30, at a point approximately 160 metres east of the said Brynawel Bungalow. (C-J-D).

Bridleway No. 32 in the community of Rhymney commencing from its junction with Bridleway No. 30 and Bridleway No. 31, approximately 300 metres north east of Brynawel Bungalow, and extending in a north then north westerly direction for approximately 207 metres, to terminate at its junction with C.R.F.27 and C.R.F.28, at a point approximately 396 metres north north east of the said Brynawel Bungalow. (C-P).

Part of Bridleway No. 33 in the community of Rhymney commencing at the Field Street entrance to the Rhymney Park and extending in a generally northerly direction for approximately 425 metres and terminating at its junction with Bridleway No. 34 and Bridleway No. 38, at a point approximately 448 metres east of Brynawel Bungalow, being that part which extends from the said point at the junction of Bridleway No.38 and Bridleway No. 34 in a southerly direction, for approximately 27 metres terminating at a point approximately 450 metres east south east of the said Brynawel Bungalow (E-F).

Bridleway No. 34 in the community of Rhymney commencing from its junction with Bridleway No. 33 and Bridleway No. 38, at a point approximately 448 metres east of Brynawel Bungalow, and extending in a northerly direction for approximately 534 metres to terminate at its junction with Bridleway No. 26 and Bridleway No. 35, at a point approximately 360 metres south east of Ffos-yr-Hebog farmstead. (E-B).

Bridleway No. 35 in the community of Rhymney commencing from its junction with Bridleway No. 26 and Bridleway No. 34, at a point approximately 360 metres south east of Ffos-yr-Hebog farmstead and extending in a north north easterly direction for approximately 152 metres, to terminate at its junction with Bridleway No. 36 and Bridleway No. 37, at a point approximately 280 metres south east of the said Ffos-yr-Hebog farmstead. (B-G).

Bridleway No. 36 in the community of Rhymney commencing from its junction with Bridleway No. 35 and Bridleway No. 37, at a point approximately 280 metres south east of Ffos-yr-Hebog farmstead, and extending in a north north easterly then north easterly direction for approximately 830 metres terminating at the county boundary approximately 650 metres east of the Upper Ras Bryn Oer farmstead (G-H).

Part of Bridleway No. 37 in the community of Rhymney commencing at its junction with Bridleway No. 35 and Bridleway No. 36, at a point approximately 280 metres south east of Ffos-yr-Hebog farmstead, and extending in a east north easterly direction approximately 760 metres to terminate at the county boundary approximately 980 metres east of the said Ffos-yr-Hebog farmstead, being that part which extends from the said point of commencement in a generally easterly direction approximately 148 metres. (G-I).

Part of Bridleway No. 38 in the community of Rhmney commencing at its junction with Bridleway No. 33 and Bridleway No. 34, at a point approximately 448 metres east of Brynawel Bungalow, and extending in an easterly then north easterly direction for approximately 785 metres, to terminate at the county boundary, approximately 1,200 metres east of the said Brynawel Bungalow, being that part extending from the said point of commencement in an easterly direction for approximately 128 metres. (E-K).

Description of Alternative Ways Proposed to be made Available

Alternative Way No. 1, from a point on Cart Road Footpath No. 27 approximately 75 metres north west of Brynawel Bungalow and extending in a generally northerly direction along the line of the site boundary for a distance of approximately 588 metres to terminate on Cart Road Footpath No. 22 at a point approximately 514 metres north of the said Brynawel Bungalow. (L-M].

Alternative Way No. 2, from a point at the commencement of Bridleway No. 29 approximately 150 metres south of Brynawel Bungalow and following a generally north easterly then south easterly direction along the line of the site boundary for aproximately 705 metres to terminate on Bridleway No. 38 at a point approximately 570 metres east of the said Brynawel Bungalow. (N-D-J-E-F-K).

Alternative Way No. 3, from a point on Bridleway No. 38 approximately 570 metres east of Brynawel Bungalow and extending a northerly then north easterly direction along the line of the site boundary for a distance of approximately 1,508 metres to terminate where Bridleway No. 36 meets the county boundary approximately 650 metres east of Upper Ras Bryn Oer farmstead. (K-I-H).
