The Trunk Road (A5) (Betws-y-Coed, Gwynedd) (Prohibition of Waiting) Order 19

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The proposed Order will alter the existing waiting restrictions in Betws-y-Coed by replacing the existing lengths of seasonal restrictions with prohibition of waiting at any time and to introduce a new prohibition of waiting at any time on the south side of the trunk road.

The effect of the proposed Order will be to prohibit (with certain exceptions) the waiting of any vehicle along the sides of the trunk road described in the schedule to this notice. The Order will also revoke the provisions of the Trunk Road (Betws-y-Coed, Gwynedd) (Prohibition of Waiting) Order 1983.

A draft Order, a copy of the Order being revoked, together with a plan and statement of reasons for making the Order, may be inspected at Betws-y-Coed Post Office, Holyhead Road, Betws-y-Coed, from 9 a.m. to 5.30 p.m. Monday to Friday, and from 9 a.m. to 12.30 p.m. Saturday.

Objections, specifying the grounds on which they are made, and quoting ref. ZC510-2-4-6, must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 22nd August 1991.

In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

Sides of the London-Holyhead Trunk Road (A5) at Betws-y-Coed in the County of Gwynedd

- The north side from a point 439 metres west of its junction with the B5106 to a point 55 metres south of the southern end of the railway bridge;
- (2) The south side from a point 174 metres west of its junction with the B5106 to a point 421 metres south-east of that junction;
- (3) The west side from a point 116 metres south of its junction with the road leading to St. Michael's Church to a point 55 metres south of the southern end of the railway bridge. (1 SI)

MEDICINES ACT 1968

EUROPEAN PHARMACOPOEIA

The Ministers, that is to say the Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, acting jointly, hereby declare under section 65(7) and (8) of the Medicines Act 1968 that on and after 1st September 1991, the revised versions of the monographs for Erythromycin and Erythromycin Stearate, adopted by the European Pharmacopoeia Commission on 19th March 1991 in replacement for monographs numbers 179/1989 and 490/1986, contained in the thirteenth and tenth fascicules respectively of the second edition of the European Pharmacopoeia, published under the direction of the Council of Europe (Partial Agreement) in accordance with the Convention on the Elaboration of a European Pharmacopoeia, are to have effect for the purposes of section 65 of the said Act.

Copies of the said revised monographs for Erythromycin and Erythromycin Stearate may be obtained from The British Pharmacopoeia Commission, Market Towers, 1 Nine Elms Lane, London SW8 5NQ on application accompanied by a stamped addressed envelope. (2 SI)

Supplement No. 3 to British Approved Names 1990

The Ministers, that is to say the Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, acting jointly, having on the recommendation of the Medicines Commission caused to be published a third supplement to British Approved Names 1990 hereby give notice under section 102(5) of the Medicines Act 1968 that the subject matter contained in the said supplement shall take effect on 1st September 1991.
