

## WIGAN METROPOLITAN BOROUGH COUNCIL

*The Wigan Borough (Brunswick Street/Ramsey Road and Mather Lane, Leigh) (Traffic Regulation) Order 1991.*

Notice is hereby given that the Wigan Borough Council, in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan Borough (Brunswick Street/Ramsey Road and Mather Lane, Leigh) (Traffic Regulation) Order 1991.

The effect of the Order will be to introduce waiting restrictions to apply at all times on the following lengths of road:

*Brunswick Street*, west side from the junction with Chapel Street for a distance of 7 metres in a southerly direction.

*Brunswick Street*, west side from a point 53 metres south of Chapel Street to a point opposite the southerly kerb-line of Ramsey Road.

*Brunswick Street*, east side from Chapel Street to Ramsey Road.

*Ramsey Road*, both sides for its whole length.

*Mather Lane*, east side from Chapel Street to the Bridgewater Canal.

*Mather Lane*, west side from Chapel Street to the Bridgewater Canal.

The Order will also revoke the Borough of Leigh (Various Streets) (Prohibition and Restriction of Waiting and One Way Streets) (No. 2) Order 1966 in so far as it relates to waiting restrictions on the said streets.

There will be limited exceptions permitting vehicles to wait—

- (a) to enable people to board or alight;
- (b) for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers;
- (c) for local authority, North West Water Ltd and Post Office purposes;
- (d) if the vehicles are fire service or police vehicles or ambulances;
- (e) to take on fuel, water or air at any garage; or
- (f) for the delivery or collection of goods and for loading or unloading.

A copy of the proposed Order, and of the relevant map, and of a statement of the reasons for proposing to make the Order, and of the Orders to be revoked, may be inspected at the New Town Hall, Library Street, Wigan and Leigh Town Hall between 9 a.m. and 4.30 p.m., on any day from Monday to Friday.

Any objection to the Order must be made in writing and specify the grounds thereof and must be made to the Borough Solicitor, New Town Hall, Library Street, Wigan, not later than 30th August 1991.

*The Wigan Borough (Westbridge Mews, Wigan) (Prohibition and Restriction of Waiting) Order 1991*

Notice is hereby given that the Wigan Borough Council, in exercise of its powers under section 1 of the Road Traffic Regulation Act 1984, has made the Wigan Borough (Westbridge Mews, Wigan) (Prohibition and Restriction of Waiting) Order 1991.

The effect of the Order is to introduce waiting restrictions as follows:

- (a) North side of Westbridge Mews from its western end for a distance of 10 metres in an easterly direction.
- (b) South side of Westbridge Mews from its western end for a distance of 5 metres in an easterly direction.
- (c) North side of Westbridge Mews, Wigan from a point 20 metres west of Harrogate Street to a point 10 metres east of its westerly end. Waiting to be limited to a period of 30 minutes between the hours of 8 a.m. to 6 p.m. on Monday, Tuesday, Wednesday, Thursday, Friday and Saturday.

A copy of the Order and of the relevant map may be inspected at the New Town Hall, Library Street, Wigan, between 9 a.m. and 4.30 p.m., on any day from Monday to Friday.

Any person who desires to question the validity of the Order or any provision contained therein on the ground:

- (a) that it is not within the powers of section 1 of the Road Traffic Regulation Act 1984; or
- (b) that any requirement of the said section 1, or of Part III of Schedule 9 to the said Act, or of any regulations made under the said Part III of Schedule 9, has not been complied with,

may within 6 weeks of 22nd July 1991, make application for the purpose to the High Court.

*Wigan Borough (New Market Street) (Bus Stop Clearway) Order 1991*

Notice is hereby given that the Wigan Borough Council in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan Borough (New Market Street) (Bus Stop Clearway) Order 1991.

The purpose of the Order is to prohibit vehicles, other than buses from waiting between 7 a.m. and 7 p.m. on any day at the bus stop in the road specified below where the carriageway at that stop is marked (a) as a bus stop and (b) with a broad yellow line adjacent to the edge of the carriageway ("the authorised markings").

The road mentioned in the above paragraph is New Market Street, Wigan, between Market Street and Mesnes Street.

Although the Order includes every bus stop in the road specified above, it should be noted that the provisions of the Order which prohibit waiting will apply only to those bus stops which the Council marks with the authorised markings.

While the Order remains in force it enables the Council at any time to lay or remove the authorised markings to or from any bus stop in a specified road or to adjust the position in that road of the authorised markings, as traffic conditions require.

Other vehicles will be permitted to wait at bus stops with authorised markings where necessary:

- (a) for the removal of an obstruction to traffic;
- (b) certain circumstances in exercise of statutory powers;
- (c) in certain emergencies; and
- (d) for police, fire brigades or ambulance purposes.

Details of these proposals are contained in a draft Order which, together with a map showing the extent of the road affected and a statement of reasons for making the Order may be inspected at New Town Hall, Library Street, Wigan, between 9 a.m. and 4.30 p.m. on any day from Monday to Friday.

Any objections to the Order must be in writing and must specify the grounds thereof and must be made to the Borough Solicitor, New Town Hall, Library Street, Wigan, no later than 30th August 1991.

*The Wigan Borough (Elizabeth Street, Leigh) (Prohibition of Waiting) Order 1991*

Notice is hereby given that the Wigan Borough Council, in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan Borough Council (Elizabeth Street, Leigh) (Prohibition of Waiting) Order 1991.

The effect of the Order will be to introduce no waiting at any time on the west side of Elizabeth Street for its full length.

There will be limited exceptions permitting vehicles to wait:

- (a) to enable people to board or alight;
- (b) for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers;
- (c) for local authority, North West Water Ltd. and Post Office purposes;
- (d) if the vehicles are fire service or police vehicles or ambulances;
- (e) to take on fuel, water or air at any garage; or
- (f) for the delivery or collection of goods and for loading or unloading.
