City of Manchester (Oak Bank, Harpurhey) (Prohibition of Waiting) Order 1991

Notice is hereby given that the Manchester City Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984, the effect of which is to prohibit waiting at any time on:

Oak Bank, Harpurhey, both sides from Rochdale Road for 35 metres west.

Exemptions are included in the proposed waiting restrictions for purposes of boarding or alighting, loading/unloading, funerals, building operations or works on or under the lengths of road. Disabled persons' vehicles displaying a disabled person's badge and a parking disc will be allowed to wait for up to 2 hours, return prohibited within 1 hour.

Manchester City Council Proposed Cycle Lane and Disabled Persons' Parking Bay—Oxford Street, City Centre

Notice is hereby given that the Manchester City Council propose to make Orders under sections 1 and 2 of the Road Traffic Regulation Act 1984. The Orders and their effects are as follows:

(1) City of Manchester (Oxford Street, Manchester) (Reserved Cycle Lane) Order 1991.

To establish a cycle lane on the south side of Oxford Street, in a north-westerly direction between (a) 82 metres south-east of Great Bridgewater Street for 49 metres north (b) 9 metres south-east of Great Bridgewater Street for 8 metres north (c) 1 metre north-west of Great Bridgewater Street for 22 metres north.

(2) City of Manchester (Various Streets, Manchester City Centre) (Disabled Persons' Parking Places) (County) Order 1980 (Amendment) Order (No. 2) 1991.

To establish a disabled parking place on the northern carriageway of Oxford Street—1 metre north-west of the Palace Theatre service access way for 15 metres north (3 vehicle spaces).

RUSHMOOR BOROUGH COUNCIL

The Borough of Rushmoor (Off-street Parking Places) (Amendment) (No. 10) Order 1991

Notice is hereby given that the Rushmoor Borough Council with the consent of the County Council of Hampshire propose to make an Order under section 35(1) and (3) of the Road Traffic Regulation Act 1984, Part IV of Schedule 9 to the Act and the Parking Act 1989 to amend, as from 1st October 1991, the Borough of Rushmoor (Off-street Parking Places) Order 1986 (as amended) by varying certain of the charges made for the use of the parking places mentioned in Schedule 1 to this Notice. The charges in respect of season tickets are shown in Schedule 2. The Order will also extend the hours of operation of the Farnborough Recreation Centre Car Park to cover the period 8 a.m. to 10.30 p.m. No charge will be payable after 6.30 p.m., as at present, but all other conditions laid down in the 1986 Order (as amended) will apply up to 10.30 p.m.
