NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To: Alistair Marshall, 'La Fosse House',

Rue Des Fosses, St. Peters,

Jersey (last known address).

Pursuant to section 139(6) of the Customs and Excise Management Act 1979, and paragraph I of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the Customs and Excise Acts and any enactments amending those Acts, certain goods, namely:

one vehicle, a 1979 Talbot Matra Baghira Registration Number J4344 (in Jersey).

has been seized as liable for forfeiture by force of the following provision namely:

Section 49(1)(a) of the Customs and Excise Management Act 1979.

Upon the grounds that the vehicle being goods chargeable on its importation with duties of Customs and Excise, namely Value Added Tax and Car Tax was without payment of these duties.

(i) unshipped at a port,

(ii) removed from their place of importation.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in writing in accordance with paragraphs 3 and 4 of Schedule 3 of the Customs and Excise Management Act 1979.

If you are outside the United Kingdom and Isle of Man you must also give the name and address of a Solicitor in the United Kingdom who is authorised to accept service of process and act on your behalf.

If you do not give notice of claim within the said period of one month or, if any requirement of the above mentioned paragraph 4 is not complied with, the goods in question will be deemed to have been duly condemned as forfeited.

If you do give notice of claim in proper form, the Commissioners will take legal proceedings for the condemnation of the said goods.
