ROAD TRAFFIC REGULATION ACT 1984

The A417 Trunk Road (Hucclecote Road, Brockworth, Gloucestershire) (Prohibition of Waiting) Order 1991

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 1(1) and (2), and 2(1) and (2) of the Road Traffic Regulation Act 1984, on part of the A417 trunk road known as Hucclecote Road, Brockworth, in the Borough of Tewkesbury. An experimental Order has been in force from 23rd May 1990 on this length of road. It is this Order which the Secretary of State is now revoking and making permanent.

The effect of the Order will be to prohibit any heavy commercial vehicles from waiting in both cul-de-sacs adjacent to the Gloucester Trading Estate Roundabout, at Hucclecote Road, Brockworth

between 2000 hours and 0700 hours, on any day.

The cul-de-sacs are close to residential properties and this prohibition is intended to eliminate the disturbance caused by noise from refrigerated lorries parking throughout the night and when

lorries start up very early in the mornings.

A copy of the Order, the Order to be revoked, a plan illustrating the proposal and a statement explaining more fully the Secretary of State's reasons for making the Order may be inspected during normal office hours at the offices of the Department of Transport, South West Region, Room 402, Tollgate House, Houlton Street, Bristol BS2 9DJ; Gloucestershire County Council, Shire Hall, Gloucester.

Any person who desires to question the validity of, or any provision contained in, the Order on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of or of any Instrument made under any provision of that Act has not been complied with in relation to the Order, may, within 6 weeks of the 21st August 1991, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
