

- (c) revise the layout of some of the resident's parking places and business parking places in each of these parking zones. Additional streets and lengths of streets have been included in the Outer Parking Zone;
- (d) introduce Health Visitor Parking Permits and Special Parking Permits which would be made available to those who are able to demonstrate a provision of health or welfare services;
- (e) introduce Resident's Visitor Parking Vouchers which would be made available to Households (50 per year at a cost of 50 pence each), which would allow visitors to park their vehicles in a resident's parking place, provided that they display a valid voucher.

Other minor and consequential changes are also included in the proposed scheme.

1. Notice is hereby given that the Council of the London Borough of Enfield propose to make:

- (a) the Enfield (Residents Parking Places) (Enfield Town Inner Zone) (No. ) Order 199 ;
- (b) the Enfield (Residents Parking Places) (Enfield Town Outer Zone) (No. ) Order 199 ;
- (c) the Enfield (Business Parking Places) (Enfield Town Inner Zone) (No. ) Order 199 ;
- (d) the Enfield (Business Parking Places) (Enfield Town Outer Zone) (No. ) Order 199 ;
- (e) the Enfield (Free Parking Places) (Disabled Persons) (No. ) Order 199 ;
- (f) the Enfield (Free Parking Places) (No. ) Order 199 ;
- (g) the Enfield (Waiting and Loading Restriction) (Amendment No. ) Order 199 ;

under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.

3. The effect of the Residents Parking Places Inner Zone Order would be to:

- (a) designate resident's parking places in Burleigh Way, Calder Close, Chalkwell Park Avenue, Chapel Street, Chase Side, Enfield, Churchbury Lane, Essex Road, Fir Tree Walk, Fyfield Road, Genotin Road, Gentleman's Row, Lincoln Road, Little Park Gardens, Raleigh Road, River Front, Roseneath Walk, St. Andrew's Road, Sydney Road, Tiptree Drive, Wilford Close, the service road fronting Nos. 43 to 63 Baker Street and the service road fronting Nos. 70 to 106 London Road at which charges may be made by the Borough Council for vehicles authorised by the Order to be left in those parking places;
- (b) provide that the parking places would operate between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (c) provide that resident's permits, bearing the letter "A", and protective covers would be issued by the Borough Council on application being made by any person residing in the streets or parts of streets listed in Schedule 1 to this notice (i.e. the Enfield Town Inner Zone controlled parking zone) who is the owner of a passenger vehicles (12 seats or less), a goods carrying vehicle not more than 2.28 metres in height, a motor cycle or an invalid carriage;
- (d) provide that health visitor permits, bearing the letter "A", and protective covers would be issued by the Borough Council on application being made by either the Director of Social Services of the London Borough of Enfield or the Unit General Manager of the Priority and Community Services Unit of the Enfield Health Authority, on behalf of an employee, provided that the employee is required to visit a person residing in a street or length of street referred to in sub-paragraph (c) above and is the owner of a vehicle of a class referred to in that sub-paragraph;

(NOTE: Each applicant would be restricted to not more than twenty health visitor permits which are or would be valid in the Inner Zone at any one time. However, health visitor permits bearing the letter "B" would be permitted to use the residents parking places in the Inner Zone);

- (e) provide that special permits, bearing the letter "A", and protective covers would be issued by the Borough Council on application being made by:

(i) a private health practitioner or a private welfare practitioner who is required to visit a person residing in a street

or length of street referred to in sub-paragraph (c) above in connection with his business and who is the owner of a vehicle of a class referred to in that sub-paragraph; or

(ii) a person required to visit an elderly or infirm resident who resides in a street or length of street referred to in sub-paragraph (c) above on a regular and frequent basis and who is the owner of a vehicle of a class referred to in that sub-paragraph;

- (f) provide that resident's visitors parking vouchers, bearing the letter "A", would be issued by the Borough Council on application being made by any person residing in the streets or parts of streets referred to in sub-paragraph (c) above in respect of a vehicle of a class referred to in that sub-paragraph:

Provided that a maximum of 50 parking vouchers per year would be supplied to any household;

- (g) provide that the charge for the issue of a resident's permit or a special permit, which would be valid for a period of 12 months running from the beginning of the month in which it first becomes valid, shall be £20;
- (h) provide that the charge for the issue of a health visitor permit, which would be valid for a period of 12 months running from the beginning of the month in which it first becomes valid, shall be £5;
- (i) provide that the charge for the issue of resident's visitor parking vouchers which, upon validation, would be valid for a period of 3 hours, would be 50 pence. These vouchers would be available in booklets comprising ten vouchers each. Up to a maximum of four valid voucher may be displayed in a vehicle at any one time. Four vouchers would allow parking all day in the parking place;
- (j) provide that certain vehicles may wait free of charge in certain circumstances, e.g. to allow persons to board or alight (maximum two minutes), to load or unload (maximum 20 minutes) and vehicles left by specified disabled person (no time limit).

4. The effect of the Residents Parking Places Outer Zone Order would be:

- (a) to designate resident's parking places in Apple Grove, Beresford Gardens, Burleigh Road, Chase Court Gardens, Chase Green, Chase Green Avenue, Chase Hill, Churchbury Close, Churchbury Lane, Eaton Road, Elizabeth Avenue, Firbank Close, Florence Avenue, Florence Drive, Gladbeck Way, Gresham Close, Ladysmith Road, Lincoln Road, Monastery Gardens, Old Park Avenue, Park Crescent, Parsonage Lane, Peartree Road, Queens Road, Enfield, Seaford Road, Shirley Road, Stanley Road, Uvedale Road, Village Road, Walsingham Road, Wellington Road and Whitethorn Gardens at which charges may be made by the Borough Council for vehicles authorised by the Order to be left in those parking places;
- (b) contain similar provisions to those set out in paragraphs 3(b), 3(g), 3(h), 3(i) and 3(j) above;
- (c) provide that resident's permits, bearing the letter "B", and protective covers would be issued by the Borough Council on application being made by any person residing in the streets or parts of streets listed in Schedule 2 to this notice (i.e. the Enfield Town Outer Zone controlled parking zone) who is the owner of a passenger vehicle (12 seats or less), a goods carrying vehicle not more than 2.28 metres in height, a motor cycle or an invalid carriage;
- (d) provide that health visitor permits, bearing the letter "B", and protective covers would be issued by the Borough Council on application being made by either the Director of Social Services of the London Borough of Enfield or the Unit General Manager of the Priority and Community Services Unit of the Enfield Health Authority, on behalf of an employee, provided that the employee is required to visit a person residing in a street or length of street referred to in sub-paragraph (c) above and is the owner of a vehicle of a class referred to that sub-paragraph;

(NOTE: Each applicant would be restricted to not more than 20 health visitor permits which are or would be valid in the Outer Zone at any one time. However, health visitor permits bearing the letter "A" would be permitted to use the residents parking places in the Outer Zone);

- (e) provide that special permits, bearing the letter "B", and protective covers would be issued by the Borough Council on application being made by:

(i) a private health practitioner or a private welfare practitioner who is required to visit a person residing in a street or length of street referred to in sub-paragraph (c) above in connection with his business and who is the owner of a vehicle of a class referred to in that sub-paragraph; or
