- (ii) a person required to visit an elderly or infirm resident who resides in a street or length of street referred to in subparagraph (c) above on a regular basis and who is the owner of a vehicle of a class referred to in that sub-paragraph;
- (f) provide that resident's visitors parking vouchers, bearing the letter "B", would be issued by the Borough Council on application being made by any person residing in the streets or parts of streets referred to in sub-paragraph (c) above in respect of a vehicle of a class referred to that sub-paragraph;

Provided that a maximum of 50 parking vouchers per year would be supplied to any household.

- 5. The effect of the Business Parking Places Inner Zone Order would be to:
  - (a) designate business parking places in Essex Road, Fyfield Road, Lincoln Road, Little Park Gardens, River Front, Sydney Road, the service road fronting Nos. 43 to 63 Baker Street and the service road fronting Nos. 70 to 106 London Road at which charges may be made by the Borough Council for vehicles authorised by the Order to be left in those parking places;
  - (b) provide that business permits, bearing the letter "A", and protective covers would be issued by the Borough Council on application being made by any person (hereinafter referred to as a "business user") who occupies premises in the streets or parts of streets listed in Schedule 1 to this notice (i.e. the Enfield Town Inner Zone controlled parking zone) and who uses such premises for non-residential purposes and in respect of a passenger vehicle (12 seats or less), a goods carrying vehicle not more than 2-28 metres in height and the overall length of which does not exceed 5-25 metres, a motor cycle or an invalid carriage;

(Note: Each business user would be restricted to not more than eight business permits which are or would be valid at any one time):

- (c) provide that the charge for the issue of a business permit:
  - (i) which would be valid for a period of 3 months running from the beginning of the month in which it first becomes valid, shall be £90:
  - (ii) which would be valid for a period of 12 months running from the beginning of the month in which it first becomes valid, shall be £348;
- (d) contain similar provisions to those set out in paragraphs 3(b) and 3(j) (except the reference to disabled persons) above.
- 6. The effect of the Business Parking Places Outer Zone Order would be to:
  - (a) designate business parking places in Chase Court Gardens, Chase Green, Chase Green Avenue, Eaton Road, Florence Avenue, Ladysmith Road, Old Park Avenue, Queens Road, Enfield and Shirley Road at which charges may be made by the Borough Council for vehicles authorised by the Order to be left in those parking places;
  - (b) provide that business permits, bearing the letter "B", and protective covers would be issued by the Borough Council on application being made by any person (hereinafter referred to as a "business user") who occupies premises in the streets or parts of streets listed in Schedule 2 to this Notice (i.e. the Enfield Town Outer Zone controlled parking zone) and who uses such premises for non-residential purposes and in respect of a passenger vehicle (12 seats or less), a goods carrying vehicle not more than 2-28 metres in height and the overall length of which does not exceed 5-25 metres, a motor cycle or an invalid carriage;

(Note: Each business user would be restricted to not more than eight business permits which are or would be valid at any one time):

- (c) contain similar provisions to those set out in paragraphs 3(b), 3(j) (except the reference to disabled persons) and 5(c) above.
- 7. The effect of the Free Parking Places Order would be to revoke the designation by the Order listed in column 1 of Schedule 3 to this Notice of the parking place allocated the number specified in column 2 of that Schedule and which is situated on the highway specified in relation thereto in that column.
- 8. The effect of the Waiting and Loading Restriction Order would be further to amend the Enfield (Waiting and Loading Restriction) Order 1979, so that:
  - (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited:
    - (i) at any time in the lengths of streets specified in Schedule 4 to this Notice;

- (ii) between 8 a.m.and 6.30 p.m. on Mondays to Saturdays inclusive in the streets and lengths of streets specified in Schedule 5 to this Notice:
- (iii) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in the street and lengths of streets specified in Schedule 6 to this Notice;
- (iv) between 8 a.m. and 9.30 a.m. on Mondays to Fridays inclusive in the length of street specified in Schedule 7 to this Notice:
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place would be prohibited:
  - (i) between 11 a.m. and 6.30 p.m. throughout the week in the lengths of streets referred to in sub-paragraph (a)(i) above;
  - (ii) between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the streets and lengths of streets referred to in sub-paragraph (a)(ii) above;
  - (iii) between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in the lengths of streets referred to in sub-paragraph (a)(iii) above;
- (c) the sale or offer for sale of goods from a vehicle in the streets and lengths of streets referred to in sub-paragraph (a) above would be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Enfield Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
- (d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the streets and lengths of streets referred to in sub-paragraphs (a) above would be prohibited:
- (e) the hours during which the existing prohibition applies on:
- (i) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be changed so that it would apply:
- (A) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 8 to this Notice:
- (B) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in the lengths of streets specified in Schedule 9 to this Notice;
- (C) between 8 a.m. and 9.30 a.m. on Mondays to Fridays inclusive in the lengths of street specified in Schedule 10 to this Notice;
- (ii) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place would be changed so that it would apply:
- (A) between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets referred to in subparagraph (e)(i)(A) above;
- (B) between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in the lengths of streets referred to in subparagraph (e)(i)(B) above.
- 9. The restrictions imposed by the Enfield (Waiting and Loading Restriction) Order 1979 would apply to any area previously designated as a parking place and not redesignated as such, as they apply in the immediate vicinity.
- 10. A copy of each of the proposed Orders, of the Enfield (Free Parking Places) Order 1967, of the Enfield (Waiting and Loading Restriction) Order 1979, the Enfield (Free Parking Places) (Disabled Persons) (No. 1) Order 1983, the Enfield (Parking Places) (Enfield Town) (No. 1) Order 1990 and the Enfield (Business Parking Places) (Enfield Town) (No. 1) Order 1990 (and of the Orders which have previously amended or applied those Orders), of a map indicating the proposals and of the Council's statement of reasons for proposing to make the Orders can be inspected at the Reception Desk, "B" Block, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD during normal office hours until the expiration of a period of 28 days from the date on which this Notice is published.
- 11. Persons desiring to object to any of the proposed Orders, or make any other representations should send a statement in writing to that effect, and in the case of an objection stating the grounds thereof, to the Borough Engineer and Surveyor, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD, quoting the reference SMG/TG52/236, within the afore-mentioned period of 28 days.
- 12. Under the Local Government (Access to Information) Act 1985, many of the reports made to a Committee of the Council are open to the press and to the public. When this happens any documents used to a material extent in compiling the report are also open to inspection. This means that any letter you may write to the
