(ii) Compulsory left turns from Coopers Road, Cobourg Road, Trafalgar Avenue and Rowcross Street into Old Kent Road would also continue to be imposed.

A compulsory right turn would be imposed for vehicles travelling in a north-westerly direction in Old Kent Road from the eastern side only of an island site to be constructed at its junction with Dunton Road into Dunton Road.
