Notice is hereby given that the Council of the London Borough of Croydon on 23rd September 1991 made the above mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

2. The general effect of the Order will be to prohibit any goods vehicle the maximum gross weight of which exceeds 7.5 tonnes from entering the area bounded by but not including Mitcham Road (between and including Grafton Road and Drake Road), Purley Way (between and including Drake Road and Miller Road, Miller Road to Thomson Crescent, Thomson Crescent to Euston Road and Euston Road to Grafton Road).

3. The prohibition referred to in paragraph 2 above will not apply:

(a) to any person causing any vehicle to enter any prescribed street for the purpose of loading or unloading in any prescribed street or for the purpose of gaining access to off-street garaging which is accessible only from any prescribed street;

(b) in relation to any vehicle when used in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for that vehicle to enter any prescribed street;

(c) in relation to any vehicle being used in connection with the maintenance, improvement, reconstruction, cleansing or lighting of any prescribed street or the laying, erection, alteration or repair of any sewer thereunder or of any main, pipe or apparatus for the supply of gas, electricity or water or of any telecommunication system thereunder or thereon or the placing, maintenance or removal of any traffic sign thereon;

(d) to anything done with the permission or at the direction of a police constable in uniform;

(e) to any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed by or on behalf of the Metropolitan Police.

4. A copy of the Order, which will come into operation on 3rd October 1991 can be inspected until the expiraton of a period of six weeks from the date on which the Order was made during normal office hours on Mondays to Fridays inclusive at the 'One Stop' facility, Ground Floor, Taberner House, Park Lane, Croydon, Surrey.

6. Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof, or of any relevant regulations made thereunder have not beem complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.
