ANIMAL HEALTH ACT 1981

Importation of Animal Products and Poultry Products Order 1980 (as amended)

Notice is hereby given that as provided by Article 4 of the Importation of Animal Products and Poultry Products Order 1980 (as amended) the Ministry of Agriculture, Fisheries and Food and the Welsh Office, Agriculture Department have, with effect from 1st

October 1991, suspended the following licences for Yugoslavia as detailed below:

Suspended Licences

A. Licence No: (a) TAY/GEN/81/691 (in England) (b) WOAD/GEN/81/45 (in Wales).

Subject: Fully cured bacon, ham, pig spare ribs (which excludes separate cuts or pieces of pig fat).

B. Licence No: (a) TAY/GEN/85/110 (in England) (b) WOAD/GEN/85/15 (in Wales).

Subject: Meat offal derived from horse, ass, mule or hinny (not for human consumption).

C. Licence No: (a) TAY/GEN/89/942 (in England) (b) WOAD/GEN/89/57 (in Wales).

Subject: Meat offal derived from cattle, sheep, goats (not intended for human consumption).

D. Licence No: (a) TAY/GEN/85/837 (in England) (b) WOAD/GEN/85/48 (in Wales).

Subject: Dry sausage (including salami).

E. Licence No: (a) TAY/GEN/86/40 (in England) (b) WOAD/GEN/86/7 (in Wales).

Subject: Petfood (heat treated in hermetically sealed containers).

F. Licence No: (a) TAY/GEN/90/243 (in England) (b) WOAD/GEN/90/8 (in Wales).

Subject: Dried milk products. (10 SI)
