The Leicester Traffic Regulation (Amendment) (No. ) Order 1991

Notice is hereby given, that Leicester City Council as agent authorised by Leicestershire County Council proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984. The effect of this Order will be to:

West Walk

- Prohibit vehicles waiting on Monday to Saturday between the hours of 8 a.m. to 6.30 p.m., except for permitted loading for a period of 20 minutes, in West Walk the north-west side, between points 13 metres and 25 metres south-west of its junction with Princess Road East.
- Prohibit vehicles waiting on Monday to Saturday between the hours of 8 a.m. to 6.30 p.m. except for limited waiting for a period of 60 minutes, in West Walk the north-west side, between its junction with Princess Road East and a point 6 metres south-west thereof.

## Wallingford Road

Prohibit vehicles waiting at any time, except for permitted loading for a period of 20 minutes, in Wallingford Road the south-east side, between a point 15 metres south-west of its junction with Corporation Road and its south-eastern extremity.

#### Everest Court

Prohibit vehicles waiting at any time, except for permitted loading for a period of 20 minutes, in Everest Court:

- (a) both sides, between a point 103 metres north of its junction with Malabar Road and its northern extremity, including the turning head.
- (b) the west side, between points 51 metres and 70 metres north of its junction with Malabar Road, including the turning head.

#### The Leicester (Bus Stops) (Clearway) (Amendment No. 2) Order 1991

The Leicester City Council as agent authorised by Leicestershire County Council, proposes to make an Order under sections 1, 2, 3, 3(2) and 4 of the Road Traffic Regulation Act 1984. The effect of this Order will be to prohibit vehicles other than buses waiting between 7 a.m. to 7 p.m. on any day at any bus stop in the road specified below where the carriageway at that stop is marked (a) as a bus stop and (b) with a broad yellow line adjacent to the edge of the carriageway.

The road mentioned above is Gedding Road both sides, between its junction with Gwendolen Road and its junction with Linden Street.

Although the Order includes every bus stop in the road specified it should be noted that it will only apply to those bus stops which the Council has marked with the authorised markings.

While the Order remains in force it will enable the Council at any time to lay or remove the authorised markings at or from any bus stop in a specified road or to adjust the position in that road of the authorised markings as traffic conditions may require.

A copy of the draft Orders, a copy at the relevant maps and the Council's statement or reasons for proposing to make the Orders may be seen at the New Walk Centre, at all reasonable hours. Any objections to the making of this Order must be made in writing to me not later than 13th November 1991 and must specify the grounds of objection.
