SCHEDULE

Prohibition of driving—as and when relevant traffic signs are displayed

(1) Central Motorway East A167(M) and Jedburgh Road A167 Northbound)

The northbound carriageway of those lengths of road, known as the A167(M) (Central Motorway East) and the A167 (Jedburgh Road) from the junction of the A167(M) and the northbound slip road from the Tyne Bridge on to Pilgrim Street Roundabout in a generally northerly direction to a point approximately 100 metres west of the overbridge at the North Terrace interchange and including all northbound slip roads. The prohibition includes the entrance to the motorway (in both directions) from Jesmond Road at its junction with Osborne Terrace.

(2) Central Motorway East A167(M) and Jedburgh Road A167 (Southbound)

(i) The northbound carriageway of the A167(M) (Central Motorway East) from the junction with its northbound slip road on to New Bridge Street Roundabout northwards for approximately 400 metres to its junction with the slip road from New Bridge Street Roundabout.

(ii) The southbound carriageway of the aforementioned highway from the junction with its southbound slip road on to New Bridge Street Roundabout for approximately 400 metres to its junction with the slip road from New Bridge Street Roundabout.

(4) Pilgrim Street Roundabout Underpass (Northbound and Southbound Carriageway)

(i) The northbound carriageway of the A167(M) (Central Motorway East) from the junction with its northbound slip road from the Tyne Bridge on to Pilgrim Street Roundabout northwards for approximately 400 metres to its junction with the slip road from Pilgrim Street Roundabout.

(ii) The southbound carriageway of the aforementioned highway from the junction with its southbound slip road on to Pilgrim Street Roundabout southwards for approximately 400 metres to its junction with the slip road from Pilgrim Street Roundabout.

(5) High Level Bridge, B1307

Northbound and southbound carriageway for its entire length. 22nd October 1991. (484)
