

Albert Road (western side) from a point 9 metres south of its junction with *Wolseley Road* to a point 17 metres north of its junction with *Recreation Road*.

Kingland Road rear service road (both sides) total length excluding the parking bay for disabled drivers only (orange badge holders) on the south side adjacent to *Coral Bingo Hall* (a length of 16.5 metres).

- (b) Impose a "no loading and unloading at any time" restriction on the following length of road:

Newfoundland Drive (both sides) from its junction with *Lagland Street* to a point 25 metres south of its junction with *Pitwines Close*. (*)

Exemptions will permit waiting for the purposes of:

- (a) picking up and setting down of passengers (except *);
- (b) the maintenance of the road/roads;
- (c) building operations;
- (d) the supply of gas, electricity and water;
- (e) funerals;
- (f) the provisions of the Local Authority's Traffic Orders (Exemptions for Disabled Drivers) (Amendment) Regulations 1986 (where appropriate).

Details of the above proposals are contained in the draft Orders which, together with maps showing the lengths of roads affected and a statement of the Council's reasons for proposing to make the Orders, may be examined at the Civic Centre, Poole, during normal office hours.
