The Trunk Road (A5) (Chirk By-pass, Clwyd and Shropshire) (Clearway) Order 1991

Notice is hereby given that on 4th November 1991, the Secretary of State made the above Order which will come into operation on 11th November 1991.

The effect of the Order is as stated in notice 4 SI in the London Gazette No. 6129 dated 19th April 1991.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

(a) that it is not within the powers of the Road Traffic Regulation Act 1984; or

(b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act

he may within 6 weeks of 11th November 1991, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

The Trunk Road (A5) (Chirk By-pass, Clwyd and Shropshire) (Prohibition of Pedestrians) Order 199

Notice is hereby given that the Secretary of State for Wales as highway authority for the trunk road in Wales, and the Secretary of State for Transport as highway authority for the trunk road in England propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit pedestrians (with certain exceptions) from proceeding in the length of trunk road (excluding laybys) specified in the Schedule to this notice.

A copy of the proposed Order, together with a plan and statement of reasons for making the Order, may be seen during normal office hours at the offices of Glyndwr District Council, Wynnstay Road, Ruthin, Clwyd; and at the offices of Owestry Borough Council, Castleview, Owestry, Shropshire.

Objections specifying the grounds on which they are made, and quoting ref: ZC510-2-1-45, must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 2nd December 1991. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
