

Copies of the Order and relevant plan may be inspected during normal office hours at the offices of Rhymney Valley District Council, Ystrad Fawr, Ystrad Mynach, Mid Glamorgan.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1990; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act,

he may within 6 weeks of the 29th November 1991 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

(All distances are approximate)

The highways to be stopped up are at Rhymney in the county of Mid Glamorgan and are:

1. That length of Cart Road footpath No. 22 which extends from a point 324 metres south-west of the Ffos-yr-Hebeg Farmstead for a distance of 44 metres in a general south-easterly direction;
2. That length of Cart Road No. 28 which extends from a point 490 metres north of the property known as Brynawel Bungalow for a distance of 100 metres in a general southerly direction;
3. That length of Cart Road footpath No. 27 which extends from a point 395 metres north of property known as Brynawel Bungalow for a distance of 315 metres in a general south-westerly direction. (496)
