### BARNSLEY METROPOLITAN BOROUGH COUNCIL

The Metropolitan Borough of Barnsley (Barnsley) (Traffic Regulation Consolidation) Order 1987 (Amendment No. 22) Order 1991.

Notice is hereby given that on 22nd November 1991, the Barnsley Metropolitan Borough Council made an order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 2nd December 1991, will be to prohibit vehicles waiting at any time along part of the north-western side of Pitt Street/Pitt Street West at either side of their junctions with St. George's Road, Barnsley.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled person's vehicles are also included in the Order.

A copy of the Order and a map showing the restricted road may be examined during normal office hours at the offices of (i) the Barnsley Metropolitan Borough Council, Town Hall, Barnsley and (ii) the Central Library, Shambles Street, Barnsley.

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order you may, within 6 weeks from 29th November 1991, apply to the High Court for this purpose.

#### BARNSLEY METROPOLITAN BOROUGH COUNCIL

The Metropolitan Borough of Barnsley (Barugh Green, Darton, Kexborough, Mapplewell and Staincross) (Traffic Regulation Consolidation) Order 1987 (Amendment No. 2) Order 1991.

Notice is hereby given that on 22nd November 1991, the Barnsley Metropolitan Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order, which will come into operation on 2nd December 1991, will be to prohibit any vehicle from waiting at any time along both sides of New Road, Staincross, which extends from its junction with Greenside Lane for a distance of 160 metres.

### BEDFORDSHIRE COUNTY COUNCIL

The County of Bedfordshire Propose to Prohibit Driving of Vehicles Over a Length of Byway Open to All Traffic No. 24 Northill Between Hatch Common and Brook End.
