## ROAD TRAFFIC ACTS

### CREWE AND NANTWICH BOROUGH COUNCIL

#### *Borough of Crewe and Nantwich (Delamere Street, Crewe) (Off-Street Parking Places) Order 1991*

Notice is hereby given that on 27th November 1991, the Crewe and Nantwich Borough Council made an Order under section 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers, with the consent of the County Council of Cheshire in accordance with section 39(3) of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act.

The effect of this Order which will come into operation on 2nd January 1992, will be to:

- restrict waiting on the Delamere Street Car Park to 2 hours at all times, Monday to Saturday (inclusive).
- impose a charge for a vehicle left in the Delamere Street Car Park of 20p. for up to 1 hour and 40p. for up to 2 hours stay between the hours of 8 a.m. to 6 p.m. Monday to Saturday. Parking will be free after 6 p.m. and before 8.30 a.m. and all day Sunday.
- impose an excess charge of £15 on vehicles which are left waiting in Delamere Street Car Park for a period in excess of the maximum 2 hours.
- revoke the current Off-Street Parking Places Orders relating to the Delamere Street Car Park.

A copy of the Order, together with a map showing the restricted area may be examined during the usual office hours at the offices of the Head of Legal Services, 7th Floor, Delamere House, Delamere Street, Crewe. Any person who desires to question the validity of the Order or of any provision contained in it on the ground that it is not
