## DEPARTMENT OF HEALTH

### MEDICINES ACT 1968

#### *European Pharmacopoeia*

The Ministers, that is to say the Secretary of State for Health, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, acting jointly, hereby declare under section 65(7) and (8) of the Medicines Act 1968, that on and after 1st January 1992, the monographs contained in the fifteenth fascicule of the second edition of the European Pharmacopoeia, published under the direction of the Council of Europe (Partial Agreement) in accordance with the Convention on the Elaboration of a European Pharmacopoeia, are to have effect for the purposes of section 65 of the said Act.

## DEPARTMENT OF THE ENVIRONMENT

### WILDLIFE AND COUNTRYSIDE ACT 1981

#### *Cumbria County Council (Underlaid Wood) Limestone Pavement Order 1991*

Notice is hereby given that on 26th November 1991, the Secretary of State for the Environment, acting under the provisions of section 34(2) and paragraphs 3(1) and 6(2) of Schedule 11 to the Wildlife and Countryside Act 1981, having considered the unopposed Cumbria County Council (Underlaid Wood) Limestone Pavement Order 1991 which took effect when it was made on 26th July 1991, decided to take no action on the Order. This means that the Order continues in force.

The Order designates the land described in the Schedule to the Order in accordance with section 34(2) of the Act and prohibits the removal or disturbance of limestone on or in that land.

Copies of the Order and map referred to in it and of this notice have been deposited at the offices of the Cumbria County Council, County Solicitor's Department, The Courts, Carlisle, Cumbria CA3 8LZJ, and may be seen free of charge at all reasonable hours.

Any person who is aggrieved by the Order and desires to question its validity on the grounds that it is not within the powers of section 34 of the said Act of 1981, or that any of the requirements of Schedule 11 of that Act had not been complied with in relation to it, may, within 6 weeks from the date of this notice make an application to the High Court under paragraph 7 of Schedule 11 to the 1981 Act.
