NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1990

The Metropolitan Borough Council of Gateshead, Coalburns Farm, Coalburn, Greenside, Public Footpath Temporary Diversion (No. 1) Order 1991.

Notice is hereby given that the Secretary of State for the environment in exercise of the powers conferred on him by section 247, 253 and 261 of the Town and Country Planning Act 1990 and all other powers enabling him in that behalf, proposes to make an Order if planning permission is granted for development to be carried out, consisting of the extraction of opencast coal to Coal Contractors Limited by the Secretary of State for the Environment. The effect of the Order will be to divert for a period not exceeding 2 years, a length of footpath running between, Coalburns and High Spen, starting from a point marked 'A' on the map which is 66 metres from the south bank of the Coalburn for a distance of 350 metres in southerly direction to a point marked 'E' on the map which is 26 metres north of Coalburn Gill, onto a new line starting from the said point marked 'A' on the map running in an easterly direction for 180 metres to a point marked 'B' on the map, then in a southerly direction for a distance of 300 metres to point marked 'C' on the map, then in a westerly direction for 160 metres to a point marked 'D' on the map and then in a southerly direction for 40 metres to the said point marked 'E' on the map.

The lines and situation on the existing and proposed alternative highway are shown on the map annexed to the Order. The proposed Order will require the restoration of the diverted length of path at the end of the end of the said period.
