TOWN AND COUNTRY PLANNING ACT 1990

The Wakefield (Stanley Public Path No. 9) Temporary Diversion (No. 2) Order 1991

Notice is hereby given that the Secretary of State for the Environment, in exercise of the powers conferred on him by sections 247, 253 and 261 of the Town and Country Planning Act 1990, and all other powers enabling him in that behalf, proposes to make an Order, if planning permission is granted for development to be carried out, consisting of the extraction of opencast coal, to H. J. Banks & Co. Limited, by the Secretary of State for the Environment. The effect of the Order will be to divert for a period not exceeding 12 months Public Path No. 9 in the Metropolitan District of the City of Wakefield, at Stanley, starting from a point 450 metres from its

junction with the (A642) Aberford Road. The lines and situations of the existing and proposed alternative footpaths are shown on the map annexed to the Order.

The proposed Order will require the restoration of the diverted length of footpath at the end of the said period.

A copy of the Order and the map annexed to it has been deposited at the offices of the City of Wakefield Metropolitan District Council, Chantry House, 123 Kirkgate, Wakefield WF1 1YG, and may be inspected, free of charge, at the Council offices during normal working hours from 3rd January 1992 to 31st January 1992.

Any representation or objection to the draft Order may be sent in writing to the Secretary of State for the Environment (Ref. YH5115/151/11), Yorkshire and Humberside Regional Office, City House, Leeds, not later than 31st January 1992, and should state the grounds on which it is made.

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of Yield Hall Lane, Yield Hall Place, part of Earley Place, the road formerly known as Gas Lane, part of Minster Street, highway/highway land on the north-west side of Mill Lane, five unnamed accessways and two footpaths at Reading in the Royal County of Berkshire. This will enable the construction of the Oracle development which will provide retail, leisure, office and residential units and a new riverside walk, together with associated car parking and service areas, to be carried out in accordance with planning permission granted by Reading Borough Council under Part III of the said Act.

The proposed Order will require that the new lengths of highway to be provided are to be highways maintainable at the public expense for which the highway authority is to be the Berkshire County Council.
