NORWICH CITY COUNCIL

The City of Norwich (Newmarket Road Bus Lane and Waiting Restrictions) Traffic Regulation Order 1992

Notice is hereby given that the City Council of Norwich, pursuant to arrangements made under section 101 of the Local Government Act 1972, with Norfolk County Council, intends to introduce a traffic regulation order, the general nature and effect of which will be to create a bus lane on the north-west (inbound) side of Newmarket Road and St. Stephens Road from Brunswick Road to a point 50 metres south-west of the St. Stephens Road roundabout, and an outbound bus lane in Newmarket Road from a point 25 metres south-west of the junction with Town Close Road to a point 50 metres north-east of the Daniels Road roundabout. Vehicles (excepting buses and pedal cycles) will be prohibited from using the bus lane between the hours of 7 a.m. to 7 p.m. Monday to Saturday inclusive. There will be the usual exceptions for emergency vehicles.

Waiting restrictions will be introduced as follows:

- St. Stephens Road—No waiting at any time. No loading from 7.30 a.m. to 9.30 a.m. and from 4.30 p.m. to 6.30 p.m. from Monday to Saturday inclusive.
- Newmarket Road—On the north-west side from a point 70 metres south-west of its junction with Brunswick Road to its junction with St. Stephens Road there will be no waiting at any time. There will be no waiting from 8 a.m. to 6.30 p.m. Monday to Saturday inclusive from a point 53 metres south-west of its junction with Allens Lane to a point 70 metres south-west of its junction with Brunswick Road. There will be no loading from 7.30 a.m. to 9.30 a.m. and from 4.30 p.m. to 6.30 p.m. Monday to Saturday inclusive from its junction with Brunswick Road to its junction with St. Stephens Road.
- Newmarket Road—South-east side. There shall be no waiting at any time from a point 60 metres south-west of its junction with Town Close Road to its junction with St. Stephens Road. There will be no loading from 7.30 a.m. to 9.30 a.m. and from 4.30 p.m. to 6.30 p.m. Monday to Saturday inclusive from its junction with Brunswick Road to its junction with St. Stephens Road.

The following documents are available for inspection at Room 300, City Hall, Norwich, during normal office hours—a copy of the Order, as drafted, a copy of the statement of reasons for introduction of this Order, a map indicating the location and effect of this Order and a copy of any traffic regulation Order it is intended to amend.

CARDIFF CITY COUNCIL

The Council of the City of Cardiff Planning (Listed Buildings and Conservation Areas) Act 1990

Designation of Churchill Way Conservation Area

Notice is hereby given that, the Council of the City of Cardiff have designated part of the land in Churchill Way, Cardiff as the Churchill Way Conservation Area pursuant to powers contained in section 69 Planning (Listed Buildings and Conservation Areas) Act 1990. The effect of the designation is as follows.

- (1) No part of any building or other structure within the Conservation Area may be demolished without the consent of the said Council.
- (2) No person shall cut down, top, lop, uproot, cause wilful damage or wilful destruction to any tree within the Conservation Area without the consent of the said Council.
- (3) Permitted development rights under Schedule 2 of the Town and Country Planning General Development Order 1988 are restricted.
- (4) Deemed consent under Class 4 of Part I of Schedule 3 of the Town and Country Planning (Control of Advertisements) Regulations 1989 is generally withdrawn in respect of illuminated advertisements on business premises.
- (5) The said Council has a duty to formulate and publish proposals for the preservation and enhancement of the Conservation Area.
- (6) In exercise of its powers under the Town and Country Planning Act 1990, the said Council shall pay special attention to the desirability of preserving and enhancing the character or appearance of that area.
