CHELTENHAM BOROUGH COUNCIL

CLEAN AIR ACT 1956

Borough of Cheltenham Area No. 19 Smoke Control Order

Notice is hereby given that Cheltenham Borough Council proposes to make an Order to be known as the "Borough of Cheltenham Area No. 19 Smoke Control Order 1992" in exercise of the powers conferred upon it by section 11 of the Clean Air Act 1956.

It is intended that the Order shall come into operation on 1st November 1992.

The effect of the Order will be:

- (a) to declare the area generally to the west of the Borough and within the south-western side of Tewkesbury Road from its junctions with Gloucester Road and Princess Elizabeth Way known as Arle, Rowanfield, Alstone, St. Marks and Fiddler's Green but excluding Hesters Way and Springbank and the area generally to the south of the A40 from the Golden Valley to its junction with Bath Road and known as The Reddings, Benhall, Hatherley, Bournside, Warden Hill, Tivoli, The Park and part of Leckhampton.
- (b) to prohibit the discharge of smoke from a chimney of any building within the said area; it will be an offence to contravene this provision; and
- (c) to prohibit the acquisition or sale of any solid fuel, other than authorised fuel, for use in the said area: it will be an offence to contravene this provision.

A copy of the draft Order and of the map referred to in it may be inspected by any person, free of charge, during normal office hours, at the Municipal Offices, Promenade, Cheltenham (Room 119), until Friday, 13th March 1992 being a period of not less than 6 weeks from the date of the last publication of this notice.
