IV. HEALTH INFORMATION

I, being an official veterinarian authorised by the competent veterinary authority of(country) to certify horses for export, hereby certify that:

- (a) I have today examined the horse identified in this certificate and found it free from clinical signs or symptoms of infectious or contagious disease (see note on page 3);
- (b) during the 12 months immediately preceding exportation, the horse was subjected to the Coggins test for equine infectious anaemia with negative result(s);
- (c) insofar as can be determined, during the last 3 months, the horse has not suffered from equine rhinopneumonitis, has not been on any premises on which this disease has occurred, and has not been exposed to this disease;
- (d) during the last 3 months the horse has not suffered from any of the following diseases:
 - equine infectious anaemia, encephalomyelitis, rabies, scabies, anthrax, glanders, dourine, epizootic lymphangitis nor any diseases of equines notifiable in the country of exportation;
- (e) during the last 3 months the horse has not been on any premises on which the above diseases have occurred, nor has the horse been exposed to the above diseases listed at paragraph IV(d);
- (f) during the last 6 months no outbreak of glanders has occurred in the country from which the horse is being exported;

the horse was tested with mallein during the 10 days immediately preceding exportation with negative result(s);

or

the horse was subjected to a complement fixation test for glanders during the last 10 days with negative result(s);

- (g) in the 24 months immediately preceding exportation no outbreak of African Horse Sickness has occurred in the country from which the horse is being exported, and no vaccination against that disease has been carried out during that time;
- (h) in the 24 hours immediately preceding exportation no outbreak of Venezuelan Equine Encephalomyelitis has occurred in the country from which the horse is being exported.


