The County of Devon (Various Streets, Paignton) (Control of Waiting, Loading and Unloading) Order 1992

Notice is hereby given that Devon County Council propose to make the above-named Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be—

- (a) to prohibit vehicles from waiting at all times in specified lengths of Belle Vue Road, Cadwell Road, Mabel Place, Manor Road, Morin Road, Roselands Drive and the Service Lane at the rear of 15-34 Winner Street;
- (b) to prohibit vehicles from waiting at all times from 1st May to 30th September (both dates inclusive) in every year in specified lengths of Belle Vue Road, Polsham Park and Stafford Road; and
- (c) to incorporate all existing waiting, loading and unloading restrictions and the above proposals into one Order.

DEVON COUNTY COUNCIL

The County of Devon (Various Streets, Brixham) (Control of Waiting, Loading and Unloading) Order 1992

Notice is hereby given that Devon County Council propose to make the above-named Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be—

DONCASTER BOROUGH COUNCIL

Doncaster Borough Council (Elmfield Residents Parking Scheme, Doncaster) (Parking Places with Permits for Residents Prohibition of Waiting) Order 1988 (Amendment) Order 1992.

Notice is hereby given that on 13th January 1992, the Doncaster Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 27th January 1992, will be to alter the prices of additional permits for households and businesses on the streets or parts of the streets set out below:

- (i) the first additional permit for households will increase in price from £50 to £55;
- (ii) the second, third and fourth additional permits for households will increase in price from £50 to £220;
- (iii) all additional permits for businesses, up to a maximum of four additional permits, will increase in price from £50 to £220.

A copy of the Order may be examined at the offices of (i) Director of Public Works, 15 South Parade, Doncaster, between the hours of 8.45 a.m. and 4.45 p.m. Monday to Fridays, and (ii) Central Library, Waterdale, Doncaster, during normal opening hours.

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 20th January 1992, apply to the High Court for this purpose.

GLOUCESTER CITY COUNCIL

The City of Gloucester (Hempsted Lane) (Weight Restriction) (Amendment No. 1) Order 1992

Notice is hereby given that Gloucester City Council, exercising the undermentioned powers of the Gloucestershire County Council under arrangements made pursuant to section 101 of the Local Government Act 1972, propose to make an Order under sections 1(1) and (2), 2(1) and (2) and 4 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to prohibit vehicles over 7.5 tonnes from travelling in Hempsted Lane between the northern junction of the access road to Netheridge Sewerage Works and the access road to Monk Meadow except for access.

Exceptions are contained in the Order to enable goods to be loaded onto or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic and the maintenance of any of the lengths of road or the services therein. An exception is also provided for the vehicle used in the service of a local authority in pursuance of statutory powers or duties.
