ROAD TRAFFIC ACTS

BIRMINGHAM CITY COUNCIL

Birmingham City Council (Yardley Green Road Bordesley Green) (Prohibition of Waiting) Order 1992

Notice is hereby given, that the above-named Council propose to make an Order under sections 1(1) (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 the effect of which will be to introduce 'no waiting at any time' on either side of the entrance to East Birmingham Hospital. Records show that double yellow lines were introduced in 1972 in this area of Yardley Green Road but neither the City Engineer or West Midlands Police can locate a Traffic Regulation Order relating to the restriction. In these circumstances it is necessary to introduce a Traffic Regulation Order to legalise the on-street restriction.

Full details of the proposals are in the draft Order which, together with a map and a statement of the Councils reasons for the proposals, may be examined at the offices of the Central Executive Department Directorate of Legal Services, Paradise Place, Birmingham B3 3EH, during normal working hours.

BRIGHTON BOROUGH COUNCIL

The Brighton (Crescent Place) (Prohibition of Driving) Order 1992

Notice is hereby given that on 7th February 1992, Brighton Borough Council acting as agents for East Sussex County Council, made the above Order under the Road Traffic Regulation Act 1984, the effect of which will be that a Prohibition of Driving will be provided as follows:
