 - (i) a route (the main route) about 15.3 kilometres in length between Hilton and Swarkestone in the county of Derbyshire, starting at a point about 364 metres west by north of the junction of the A516 Trunk Road with Lucas Lane and Willowpit Lane at Hilton and terminating at a point on the A514 (Swarkestone Road) 150 metres south-west of the southern boundary of the property known as Windmill Cottage, Swarkestone;

(ii) routes for slip roads to connect the main route to existing roads at Hilton and routes for a roundabout and slip roads to connect the main route with existing roads at Swarkestone.

- (b) an Order under sections 10, 41 and 106 of the Highways Act 1980, entitled The A564 Trunk Road (Stoke-Derby Route) (Derby Southern By-pass and Slip Roads) (No. 2) (Order 1992 which provides that roads which he proposes to construct along the following routes shall become trunk roads as from the date when the Order comes into force:
 - (i) a route (the main route) about 8.83 kilometres in length between Swarkestone in the county of Derbyshire and Lockington—Hemington in the county of Leicestershire, starting at a point on the A514 (Swarkestone Road) 150 metres south-west of its junction with the southern boundary of the

property known as Windmill Cottage and terminating at a point on the A6 Trunk Road about 470 metres north of its junction with Netherfield Lane;

(ii) routes for slip roads to connect the main route to existing roads at Swarkestone and a roundabout and slip roads to connect the main route with existing roads at Lockington.

- (c) an Order under sections 10 and 41 of the Highways Act 1980, entitled The A564 Trunk Road (Stoke-Derby Route) (Derby Southern By-pass) (Burnaston Slip Roads) Order 1992 which provides that roads which he proposes to construct along the following routes shall become trunk roads as from the date when the Order comes into force:
 - (i) a roundabout, the centre point of which is about 150 metres north-east of the junction of the A38 Trunk Road, Willington Road and Etwall Road;
 - (ii) four routes for slip roads to connect the road described at paragraph (a)(i) above to that roundabout;
 - (iii) four round routes for slip roads to connect the A38 Trunk Road to that roundabout.
