**TOWN AND COUNTRY PLANNING ACT 1990**

*Beverley (Footpath No. 1 in the Parish of Ellerker) Public Path Diversion Order 1991*

Notice is hereby given that the Secretary of State for the Environment in exercise of the powers conferred on him by section 247 and section 253 of the Town and Country Planning Act 1990, and of all other powers enabling him in that behalf, proposes to make an Order. If planning permission is granted by him for

development involving the erection of 3 dwellings on 0.2ha of land at Croft Garth, Mill Hill, Ellerker. The effect of the Order will be to divert Footpath No. 1 on sheet 1 of the Humberside County Council Definitive Map from Mill Hill Beck, northwards, then eastwards to the north-east corner of the proposed development site, a distance of approximately 67 metres.

The lines and situations of the existing and proposed alternative footpath are shown on the map annexed to the Order.

**TOWN AND COUNTRY PLANNING ACTS 1971 AND 1990  
ACQUISITION OF LAND ACT 1981**

**WILDLIFE AND COUNTRYSIDE ACT 1981**

*Cumbria County Council (Marble Quarry and Hale Fell) Limestone Pavement Order 1991*

Notice is hereby given that on 25th February 1992 the Secretary of State for the Environment, acting under the provisions of section 34(2) and paragraphs 3(1) and 6(2) of Schedule 11 to the Wildlife and Countryside Act 1981, having considered the unopposed Cumbria County Council (Marble Quarry and Hale Fell) Limestone Pavement Order 1991 which took effect when it was made on 26th July 1991, decided to take no action on the Order. This means that the Order continues in force.

The Order designates the lands described in the Schedule to the Order in accordance with section 34(2) of the Act and prohibits the removal or disturbance of limestone on or in that land.

Copies of the Order and map referred to in it and of this notice have been deposited at the offices of the Cumbria County Council, County Solicitor's Department, The Courts, Carlisle, Cumbria CA3 8LZJ, and may be seen free of charge at all reasonable hours.

All person who is aggrieved by the Order and desires to question its validity on the grounds that it is not within the powers of section 34 of the said Act of 1981, or that any of the requirements of Schedule 11 of that Act had not been complied with in relation to it, may within 6 weeks from the date of this notice make an application to the High Court under paragraph 7 of Schedule 11 to the 1981 Act.
