##### *Proposed Alteration of Rights of Way at Druids Lodge, Parishes of Woodford and Stapleford, in the District of Salisbury*

#### SCHEDULE

##### *By-way Open to All Traffic (By-way) 15, Woodford*

The diversion of all public vehicular rights over a Length of By-way 15, Woodford from its junction with Road A360 in a generally south-westerly direction to the Stapleford/Woodford Parish boundary on the grounds that an alternative by-way will be provided which will be nearer or more commodious to the public. Public bridleway rights would be retained over the existing route.

##### *Road Used as Public Path (RUPP) 4, Stapleford*

The diversion of all public vehicular rights over a length of RUPP 4, Stapleford from the Stapleford/Woodford Parish boundary in a generally south-westerly direction for a distance of 26 metres on the grounds that an alternative by-way will be provided which will be nearer or more commodious to the public. Public bridleway rights would be retained over the existing route.

##### *An Unnumbered Right of Way (X)*

The stopping-up of all public rights on an unnumbered right of way over its entire length from its junction with By-way 15, Woodford in a generally south-easterly direction to its junction with Road A360 on the grounds that it is unnecessary for public use.

##### *An Unnumbered Right of Way (Y)*

The stopping-up of all public rights on an unnumbered right of way over its entire length from its junction with By-way 15, Woodford in a generally south-easterly direction to its junction with road A360 on the grounds that it is unnecessary for public use.

##### *An Unnumbered Right of Way (Z)*

The stopping-up of all public vehicular rights on an unnumbered right of way over its entire length from its junction with By-way 15, Woodford in a curving north-easterly then south-easterly direction to its junction with road A360 on the grounds that vehicular and bridleway rights are unnecessary for public use. Public bridleway rights would be retained.
