## HIGHWAYS ACTS

HIGHWAYS ACT 1980—SECTION 119

*Carmarthen District Council Public Footpath No. 61/10 Pothouse Wharf, Carmarthen to Rhydygors, Johnstown, Carmarthen Public Path Diversion Order 1992.*

Notice is hereby given that on 21st May 1992, the Carmarthen District Council confirmed the above-named Order.

The effect of the Order will be to extinguish that part of Public Footpath No. 61/10 from Point 'C' to Point 'D' which is coloured brown on the map annexed to the Order and is approximately 100 metres in length. There will then be a Public Footpath over the land situate at the B & Q Store, which is shown coloured purple on the said map and will be 2 metres minimum width and will run for a distance of approximately 101 metres between Point 'B' and Point 'D' on the said map. The level of the new footpath will correspond to the average level of the existing path, being 4.62 metres AOD.

A copy of the confirmed Order and the map contained in it has been deposited and may be inspected free of charge at the Council Offices at 3 Spilman Street, Carmarthen, between 9 a.m. to 5 p.m. on Monday to Thursday and 9 a.m. to 4.15 p.m. on Friday. Copies of the Order and the map may be purchased.

The Order becomes operative 36 days from the date of the confirmation of the Order but if any person aggrieved by the Order desires to question the validity thereof or of any provisions contained therein on the grounds that it is not within the powers of the Highways Act 1980, or on the grounds that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may within 6 weeks from 27th May 1992, make application to the High Court.
