SCHEDULE 1

- (i) to compute and arrange for payment to the Concessionaires of "Usage Charges", for reimbursement to the Concessionaires of "Operating Costs" and for payment to the Concessionaires of other amounts which the Usage Contract specifies are so payable by BR and SNCF,
- (ii) to compute and seek recovery from the Concessionaires of "Usage Charge Reductions" and other amounts which the Usage Contract specifies are payable by the Concessionaires to BR or SNCF,
- (iii) to audit or arrange for the audit of amounts claimed by the Concessionaires from BR and SNCF under the Usage Contract,
- (iv) to operate, on behalf of the parties thereto, the provisions of such Inter Railway Agreements as the Members may specify,

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (County of Northumberland) (No. 4) Order 1992" authorising the stopping-up of a length of Oak Street and sections of Elm Street, Alnwick, to enable development consisting of the modernisation and remodelling of dwellings, to be carried out in accordance with planning permission granted by Alnwick District Council under part III of the Town and Country Planning Act 1990.

The Order also requires the provision of new and improved highways maintainable at the public expense, for which the highway authority is to be the Northumberland County Council.

Copies of the Order may be obtained, free of charge, on application to the Director Network Management and Construction, Northern Region, Department of Transport, Wellbar House, Gallowgate, Newcastle upon Tyne NE1 4TD (Quoting ref. DN 506835/1/77) and may be inspected at all reasonable hours at the offices of the Alnwick District Council, Allerburn House, Alnwick, Northumberland NE66 1YY.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 10th June 1992, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

BRITISH GAS PLC

Notification by a public gas supplier of intention to execute works for the construction of high pressure pipelines

In accordance with section 20(1) of the Gas Act 1986 (c44), the Director General of Gas Supply has received notice from British Gas plc, a public gas supplier within the meaning of that Act, of its intention to execute works for the construction of a high-pressure pipeline for the conveyance of Natural Gas or Substitute Natural Gas, as follows:

Copies of the notice, and of the accompanying map delineating the route which the proposed pipeline is to take, may be inspected free of charge, between 10 a.m. and 4 p.m. Monday to Friday, in the Library of the Office of Gas Supply, Southside, 105 Victoria Street, London SW1E 6QT (telephone 071-828 0898 for an appointment). Copies may also be purchased from the Library, at a cost of £1 for up to and including five pages, and £0.10 per page thereafter (including VAT), by personal callers between the times given above, or by postal request made payable to the Office of Gas Supply.

Sections 20(4) and (5) of the Gas Act 1986, provide that the Director General of Gas Supply may give directions as to the capacity of a proposed pipeline and as to the cost of its construction, if satisfied in the light of representations;

- (a) that a demand exists or is likely to arise for the conveyance of gas of, or of a kind similar to, the kind specified in the notice relating to a proposed pipeline; and
- (b) that the routes along which the gas will require to be conveyed will severally be, as to the whole or any part thereof, the same or substantially the same as the route or any part of the route so specified.

Any representations as to such matters should be made in writing and delivered to the Director General of Gas Supply, Office of Gas Supply, Southside, 105 Victoria Street, London SW1E 6QT, in such manner that:

- (a) an indication in respect of the gas for the conveyance of which a demand may exist or be likely to arise, of
 - (i) its origin,
 - (ii) its quantity; and
 - (iii) the rate at which it may be conveyed,
 is delivered within 28 days of publication of this notice; and
- (b) any other and further representations are delivered within 90 days of publication. (14 SI)
