##### *The East Sussex (Roads in Wealden District) (Prohibition of Waiting) Order 1992*

Notice is hereby given that East Sussex County Council have made an Order on 8th July 1992, coming into operation on 13th July 1992 under sections 1(1) and (2), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, which introduces No Waiting At Any Time waiting restrictions along certain lengths of roads in the Wealden District.

##### *Crowborough—No Waiting "At Any Time"*

- (i) *Maynards Mead UC7154*, northside, from a point 73 metres west of its junction with Sybron Way, westwards for a distance of 163 metres.

##### *Parish of Polegate—No Waiting "At Any Time"*

- (i) *Brightling Road UC7342* (Northern most arm), north-east side, from its junction with the eastern kerb-line of Church Road, south-eastwards for a distance of 10 metres.

- (ii) *Church Road UC7342:*

East side, from a point 20 metres north of the north-western kerb-line of St. John's Road, southwards for a distance of 38 metres.

West side, from a point opposite the boundary between Nos. 9 and 11 Church Road, southwards for a distance of 119 metres.

- (iii) *St. John's Road UC7342*, both sides, from its junction with the eastern kerb-line of Church Road, north-eastwards for a distance of 19 metres.
