indicated in relation to that length of road in column 2 of the said Schedule;

(c) to revoke the existing waiting restrictions in the lengths of road specified in Schedule 3 to this notice;

- (d) to revoke the County of Avon (Thornbury, District of Northavon) (Prohibition of Driving) Order 1974 the provisions of which are contained in this Order with the exception of Horseshoe Lane, this road having ceased to exist;
- (e) to revoke the County Council of Avon (Thornbury) ('Doctor' Parking Places) Order 1980 the provisions of which are no longer required, and
- (f) to consolidate existing prohibitions and restrictions in the area. These remain unaltered on site but because of the conversion of imperial measurements to the metric equivalent and new datum points, some measurements have changed (this conversion has been carried out to two decimal places). The roads affected only by this item are listed in Schedule 4 to this notice.

Exemptions in the Order permit any vehicle to wait for the purpose of boarding or alighting; loading or unloading goods; Post Office services; maintenance of the road; supply of gas, water or electricity; the pursuance of statutory powers or duties; taking in petrol, oil, water or air from any garage; weddings or funerals; being a hackney carriage to wait upon an authorised cab rank and in accordance with the current provisions for disabled persons' vehicles.

Full details of the proposal are contained in the draft Order, which together with maps and a statement of the Council's reasons for proposing to make the Order and copies of the Orders to be revoked may be inspected at the undermentioned offices (callers should report to Reception and ask for the Statutory Orders Section) and at Northavon District Council Offices, Castle Street, Thornbury, during normal office hours.

Castle Court:

- North-east side, from 120 metres generally west of High Street to its westernmost closed extremity.
- South-west side, from 104-24 metres generally west of High Street to and including all sides of its southern spur and westernmost extremity.

Castle Street:

South-west side, (a) from 77.72 metres south-east of Kington Lane to 45 metres north-west of Stokefield Close, (b) from 25 metres north-west of Stokefield Close to Stokefield Close.

Cooper Road:

Both sides, from 20 metres north of Short Way to 20 metres south of Short Way.

Gillingstool (formerly known as Grovesend Road):

North side, from 30.1 metres east of Pullens Green eastwards for 50 metres.

South side, from 30-1 metres east of Pullens Green to 90 metres east of Rock Street.

Gloucester Road:

Both sides, from 154.53 metres north-east of St. John Street/The Plain to Stafford Crescent.

- East and south-east side, (a) from 122 metres south-west of Eastland Road to Eastland Road, (b) from 136 metres northeast of Eastland Road north-eastwards for 30 metres, (c) from 23 metres north-east of Whitfield Road north-eastwards for 30 metres, (d) from 35 metres north-east of Park Road northwards for 45 metres.

Both sides, from Midland Road northwards for 15 metres.

Tanners Court (main carriage only)

Both sides, whole length.

The Close

North and west side, whole length including its western closed end.

Streamleaze:

East side, from Rock Street/Chapel Street to 15 metres north of Midland Road.

St. John Street:

North-east side, from 8 metres north-west of Rock Street/Saw Mill Lane north-westwards for 76 metres (currently 'No Waiting At Any Time').

Stokefield Close:

Both sides, from 50 metres generally south-west of Castle Street southwards to and including, it southernmost closed end.

Part IV-Limited Waiting, 8 a.m. to 6 p.m., Monday to Saturday (inclusive) 1 hour in any 2 hourly period

High Street:

West side, from 220.37 metres south of Castle Court southwards for 21 metres (part of this length currently Limited Waiting, 8 a.m. to 6 p.m., Monday to Saturday (inclusive), 1 hour in any two hourly period).

The Plain

South side, (in the lay-by) from 9-14 metres east of High Street eastwards for 16-45 metres (currently No Waiting, 8 a.m. to 6 p.m., Monday to Saturday (inclusive)).

Part V—Limited Waiting, 8 a.m. to 6 p.m., Monday to Friday (inclusive) 2 hours in any 4 hourly period

Castle Street:

North-east side, from The Plain to 77.72 metres south-east of Kington Lane (currently 'Limited Waiting, 8 a.m. to 6 p.m., Monday to Saturday (inclusive), 1 hour in any 2 hour period').
