THE HIGHWAYS ACT 1980

The Chester-Bangor Trunk Road (A55) (St. Asaph Business Park Slip Roads) Order 1992, and

The Chester-Bangor Trunk Road (A55) (St. Asaph Business Park Side Roads) Order 1992

The Secretary of State for Wales hereby gives notice that he has made the following Orders:

1. An Order under sections 10 and 12 of the Highways Act 1980 which will provide that roads which he proposes to construct along the following routes shall become trunk roads as from the date when the Order comes into force:

four slip roads to connect the existing A55 with a proposed interchange consisting of a bridge over the A55 and two roundabouts and a link road to the proposed St. Asaph Business Park.

- 2. An Order under sections 14 and 125 of the Highways Act 1980:
 - (a) authorising him:
 - (i) to stop-up highways;
 - (ii) to construct new highways;
 - (iii) to stop-up private means of access to premises; and
 - (iv) to provide new private means of access to premises

all or in the vicinity of the route of the new trunk road mentioned above: and

(b) providing for the transfer of each new highway to the County Council of Clwyd as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.
