Paterbaurg Jan. 21. Yesterday being the Day of Thanks. piving for the King of Great Britain's happy Accession to the Throne, Mr Mackenzy his Majesty's Resident here entertained at Dinner all the Foreign Ministers, with some Persons of Distinction of this Court, several Ladies, and the principal Merchants of the British Nation to the Number of 54 in all. Stockholm. Jam. 29 The 20th of this Month being the Day appointed in Great Britain for returning Thanks to God for his Majesty King George's Accession to the Throne, the same was observed here by the Subjects of the British Nation with all Demonstrations of Duty and Loyalty. In the Forenoon Divine Service was performed in the House of Mr. Jackson his Britannick Majesty's Resident, and a Sermon suited to the Occasion was preached by Mr. Dubordies the Resident's Chaplain.
