CUSTOMS AND EXCISE

In the High Court of Justice Queen's Bench Division

In the Matter of PAUL ROGER GUNNELL and in the Matter of the Drug Trafficking Offences Act 1986

Take notice Paul Roger Gunnell that an application for the appointment of a Receiver to realise sufficient of your assets for the purposes of satisfying a confiscation Order made against you has been presented to this Honourable Court by H.M. Customs and Excise, of New King's Beam House, 22 Upper Ground, London SE1 9PJ.

This application will be heard on 5th October 1992, at the Royal Courts of Justice, Strand, London.

The Honourable Court may, on the application of H.M. Customs and Excise make an Order for the appointment of a Receiver who will be empowered to sell your assets and apply the gross proceeds of such sale to the satisfaction of the aforementioned confiscation Order.

The application can be inspected by you upon application to the Crown Office, Royal Courts of Justice, Strand, London.

You are entitled, if you see fit, by yourself or Counsel, to make representations to the Court on 5th October 1992, as to whether such an Order should be made.

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping up of Highways (county of Durham) (No. 11) Order 1992" authorising the stopping up of two areas of unnamed highway, one connecting with High Street and the other with Mechanic Street, West Cornforth, in the county of Durham, to enable development of a small environmental improvement scheme consisting of change of use from highway to landscaped open space and Public Car Park to be carried out in accordance with planning permission deemed granted to Sedgefield District Council under Part III of the Town and Country Planning Act 1990.

Copies of the Order may be obtained, free of charge, on application to the Director Network Management and Construction, Northern Region, Department of Transport, Wellbar House, Gallowgate, Newcastle-upon-Tyne NE1 4DT (quoting ref. DN 5053/35/1/241 and may be inspected at all reasonable hours at the offices of the Sedgefield District Council, Spennymoor, County Durham.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 21st September 1992, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

ROAD TRAFFIC REGULATION ACT 1984

*The A14 Trunk Road (Chainbridge Lane, Molesworth)
(Prohibition of Right-turn) Order 1992*

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 1(1) and (2), and 2(1) and (2) of the Road Traffic Regulation Act 1984 and of all other enabling powers on the A14 Trunk Road.

The effect of the Order, if made, will be to prohibit vehicles proceeding the westbound carriageway from making a right hand turn in Chainbridge Lane at Molesworth in the district of Huntingdonshire in the county of Cambridgeshire.

A copy of the proposed draft Order, together with a plan illustrating the proposal and a statement explaining the Secretary of
