Proposed Stopping-up of a Highway at Caldershaw, Rochdale

## **HIGHWAYS ACT 1980**

The A556(M) Motorway (M6-M56 Link) and connecting Roads Scheme 199

The A556(M) Motorway (M6-M56 Link) and connecting Roads (Side Roads) Order 199

The A556 Trunk Road (Church Farm-Turnpike Wood, Over Tabley) Order 199

The A556 Trunk Road (Turnpike Wood, Over Tabley - A56 Bowdon Roundabout) (Detrunking) Order 199

The Secretary of State for Transport hereby gives notice that he proposes in relation to the A556(M) Motorway (M6-M56 Link) which will be situated between Over Tabley and Bowdon in the County of Cheshire to make:

- (1) A Scheme under sections 16, 17 and 19 of the Highways Act 1980 which will authorise him to provide for the exclusive use of traffic of Classes I and II of the classes of traffic set out in Schedule 4 to the Highways Act 1980. The proposed scheme will authorise a special road ("the Motorway") about 8.89 kilometres in length northbound and 7.43 kilometres in length southbound from the M6 Motorway at Over Tabley to the M56 Motorway at Bowdon in the County of Cheshire and, authorise provision of six special roads to connect the motorway with other highways.
- (2) An Order under sections 12, 18 and 125 of the Highways Act 1980, which:
  - (a) will authorise him to carry out the following works -
  - (i) improvement of each highway named in a Schedule and shown on a plan by cross hatching;
  - (ii) stopping up of each length of highway described in a Schedule and shown on a plan by zebra hatching;
  - (iii) construction of a new highway along each route whose centreline is shown on a plan by an unbroken black line surrounded by stipple;
  - (iv) stopping up of each length of private means of access to premises described in a Schedule and shown on a plan by a solid black band: and
  - (v) provision of a new private means of access to premises along each route or at each location shown on a plan by thin diagonal hatching;
  - all on or in the vicinity of the Motorway and special roads referred to in (1) above; and
  - (b) provide for the transfer of each of the said new highways to the highway authority specified in the Order as from the date on which he notifies that authority that the new highway has been completed and is open for through traffic.
- (3) An Order under section 10 of the Highways Act 1980, authorising him to provide a new trunk road about 0.08 kilometres in length starting at a point on the A556 Trunk Road 415 metres north of the junction with Moss Lane to a point 495 metres north of the same junction (between two new roundabouts as proposed to be constructed by the Secretary of State pursuant to (2) above), all at Over Tabley in the County of Cheshire.
- (4) An Order under section 10 of the Highways Act 1980, to provide that a length of the A556 Trunk Road, to be superseded by the new trunk roads on the route described at (1) above, shall cease to be a trunk road and shall be classified as a principal road, as from the date on which the new trunk roads are open for traffic.
