HIGHWAYS ACT 1980

The A31 Trunk Road (A31/B3074 Broadstone Junction, Corfe Mullen Side Roads) Order 1992

HIGHWAYS ACT 1980

The Devon County Council (Tavistock Inner Relief Road, Classified Road) (Side Roads) Order 1990
